COLONIAL STOCK ACT, 1900. (63 and 64 Vict. c. 62.)

LIGHT RAILWAYS ACT, 1896. Bentley and Bordon Light Railway Order.

The Light Railway Commissioners have submitted to the Board of Trade, for confirmation under the above-mentioned Act, an Order made by them for the construction of a Light Railway in the county of Southampton from Bentley to Bordon.
