ARTICLE 1. The health or lazaret doctors, according to circumstances, will require from the Captains of Ocean Steamers a certificate issued by the Sanitary Authorities at the port of embarkation and viséd by the Uruguayan Consul, stating which of the third class passengers have been vaccinated or revaccinated previous to embarkation.

ARTICLE 2. Should vaccination or revaccination have been performed on board during the voyage, the captain and ship's doctor will sign a joint declaration to that effect, which will be handed to the health doctor together with a list of persons so vaccinated or revaccinated.

ARTICLE 3. The provisions of Article 1 will hold good even if small-pox is not prevalent either at the port of origin or at the ports of call, and even when no cases have occurred during the voyage.

ARTICLE 4. After the health visit has taken place all third class passengers for Montevideo, who are not included in the provisions of Articles 1 and 2, shall be vaccinated.

ARTICLE 5. Passengers for other ports who wish to land at Montevideo, are at liberty to do so provided the provisions of Articles 1, 2, and 3 have been carried out.

ARTICLE 6. No third class passenger may land without presenting a certificate of vaccination or submitting to vaccination. Captains of ships will be responsible should any one land in contravention to the above.

ARTICLE 7. Vessels which have had cases of small-pox on board will on arrival be subjected to the measures laid down in Ordinance No. 27 of 7th September, 1899.

ARTICLE 8. Should the Board deem it necessary the vaccination and revaccination of passengers may be enforced on those coming from the Argentine Republic, Paraguay, and Matto Grosso.
