Cape Corrientes-Light Reported Established. The United States Government has given notice, dated 7th February, 1903, that the Master of the steamship "City of Para" reports that a white flashing light is now exhibited from Cape Corrientes Lighthouse.

Previous information received shows that it was intended to exhibit a white flashing light every minute, elevated 269 feet above high water, and visible in clear weather from a distance of 24 miles from the lighthouse which was being built on Cape Corrientes; it has therefore been placed on the charts with the above characteristics in that position.
