BECKENHAM URBAN DISTRICT COUNCIL.

(Petition for Additional Provision to authorize the Purchase of Additional Lands at Beckenham.)

NOTICE is hereby given that the Urban District Council of Beckenham in the county of Kent (hereinafter called "the Council"), intend to apply to Parliament by Petition for Additional Provision for leave to introduce into the Bill now pending in Parliament under the above name or title, amendments to effect all or some of the following purposes (that is to say):—

To empower the Council to purchase by compulsion or agreement, in addition to the lands mentioned in Clause 6 of the Bill, the lands hereinafter described, which last mentioned lands are included in the Notices for the said Bill as published in the month of November last in the London Gazette and local newspapers, and are shown upon the plans and described in the books of reference deposited on or before the 30th day of November last, with reference to the said Bill, with the Clerk of the Peace for the county of Kent at his office at Maidstone, and with the Clerk of the Urban District Council of Beckenham, but which lands were inadvertently omitted from the said Bill as deposited in the Private Bill Office of the House of Commons on or before the 20th day of December last.

The lands hereinbefore referred to are situate in the urban district of Beckenham, and are:—

Lands situate on the north side of High-street partially bounded on the west by a fence, distant 2·20 chains or thereabouts from Rectory-road, and on the east by the "The Cedars" and grounds connected therewith, and having an average depth from High-street of 2·50 chains or thereabouts.

Lands situate on the north side of High-street extending from and inclusive of premises Nos. 102 to 108, High-street, bounded on the west by the coach house and grounds attached to "The Cedars," and on the north by premises No. 100, High-street, and its curtilage.

Lands situate on the south side of High-street, bounded on the south by the passage and yard situate on the north side of shop No. 67, High-street, and by Christ Church Villas, on the east side by Fairfield-road and Christ Church Villas.

Lands abutting on the south-east side of Croydon-road and extending from the northern boundary of the recreation ground to a point 0·50 chain south of the junction of Croydon-road and High-street.

Land abutting on the south side of Croydon-road, situate between Langley-road and Eden-road, and forming part of the forecourts of houses Nos. 19 to 39 inclusive, and Nos. 43 to 45 and shops Nos. 47 to 51 inclusive.

Land abutting on the north side of Bromley-road and extending from "The Knoll" to Westgate-road.

Land on the east side of Scott's-lane extending south of Bromley-grove for a distance of 2 chains or thereabouts measured in a southerly direction.

Land at the south-west corner of Hayes-lane at its intersection with Wickham-road, extending for a distance of 2·20 chains or thereabouts in Hayes-lane measured in an easterly direction,

and 1·30 chains or thereabouts in Wickham-road measured in a southerly direction.

THE JEWISH COLONIZATION ASSOCIATION.

(Extension of powers of Association; Amendment of Memorandum of Articles of Association; Provisions as to application of income under Trust Deed; Extension of Powers of Investment, &c.)

NOTICE is hereby given, that application is being made to Parliament in the present Session by a Bill which has been introduced into and is now pending in the House of Lords by the Jewish Colonization Association, hereinafter called "the Association" for an Act for all or some of the following purposes, that is to say:—

To alter, amend, extend, and enlarge the Memorandum of Association, so as to include therein powers to the Association to establish and maintain, or to contribute towards the establishment and maintenance of educational and training institutions, model farms, loan banks, industries, factories, and any other institutions or associations, which in the judgment of the Council of Administration of the Association may be calculated to fit Jews for emigration and assist their settlement in various parts of the world, with power to contribute to the funds of any Association or Society already existing, or hereafter formed, and having for its object the promotion of the welfare of Jews in any part of the world.

To provide that the income of the Association derived under an indenture dated the 26th day of August, 1892, and made between Baron Maurice de Hirsch of the one part and the Association of the other part, hereinafter called "the Trust Deed," may be applied for the benefit of Russian Jews by any methods, in addition to the method particularly specified in the Trust Deed, which in the judgment of the Council of the Association may be calculated to improve the condition of Russian Jews in any part of the world.

To extend the powers of investment contained in the Memorandum of Association, and to authorize the Association to invest their funds or any moneys under their control in the purchase of freehold ground rents, and in any investment in which trustees are for the time being authorized to invest trust moneys and from time to time to vary any investment made by them either before or after the passing of the intended Act.

To amend the Memorandum of Association in such further particulars as may be necessary or expedient. To vary or extinguish all existing rights, interests, and privileges which would or might interfere with any of the objects and purposes of the intended Act, and to confer other rights and privileges.

Printed copies of the Bill for the intended Act have been deposited in the Private Bill Office of the House of Commons.
