Harley Wood which is described in the Schedule hereunder written all which part together with the boundaries thereof is delineated and set forth on the map or plan hereunto annexed should be assigned as a district chapelry to the said church of Saint Michael and all Angels situate at Cornholme as aforesaid and that the same should be named 'The District Chapelry of Saint Michael and All Angels Cornholme.' And with the like consent of the said George Rodney Bishop of the said diocese of Wakefield (testified as aforesaid) we the said Ecclesiastical Commissioners further represent that it appears to us to be expedient that banns of matrimony should be published and that marriages baptisms churchings and burials should be solemnized or performed at the said church of Saint Michael and All Angels situate at Cornholme as aforesaid and that the fees to be received in respect of the publication of such banns and of the solemnization or performance of the said offices should be paid and belong to the minister of the same church for the time being. Provided always that nothing herein contained shall be construed as expressing any intention on the part of us the said Commissioners to concur in or approve the taking of any fee for the per-formance of the said office of baptism or for the registration thereof.

"We therefore humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration and to make such Order with respect thereto as to Your Majesty in Your Royal wisdom

shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The District Chapelry of Saint Michael and

All Angels Cornholme being:-

"All that part of the new parish (sometime consolidated chapelry) of All Saints Harley Wood partly in the county of York and partly in the county of Lancaster and wholly in the diocese of Wakefield which is bounded upon the south by that portion of the said new parish of All Saints Harley Wood which by an Order in Council dated the twenty-ninth day of January one thousand eight hundred and ninety-four was prospectively annexed to the parochial chapelry of Todmorden in the said counties of York and Lancaster and in the diocese of Manchester upon the north-west by the new parish of Saint John Holme in the said county of Lancaster and in the said diocese of Mauchesterupon the north-east by the chapelry of Cross Stone in the said county York and in the said diocese of Wakefield and upon the remaining side that is to say upon the south-east by an imaginary line commencing upon the boundary which divides the said chapelry of Cross Stone from the said new parish of All Saints Harley Wood at the junction of the road known as Stiperden Bank with Sagar-lane and extending thence south-westward along the middle of Sagar-lane for a distance of thirtysix chains or thereabouts to its junction with Blue Bell-lane and extending thence eastward along the middle of Blue Bell-lane for a distance of one chain or thereabouts to its junction with the roadway leading to the house called Mercer Field and extending thence southward along the middle of the said roadway for a distance of twelve chains and a half or thereabouts to the point where it is crossed by the footpath leading from the house called Hartley Royd to the house called Hullet and extending thence southward and in a straight line (thereby passing to the west of the said house called Mercer Field) for a distance of fifteen chains and a half or thereabouts to the north-eastern corner of the house

known as New Ley and extending thence southward to and then first westward then southward then again westward then again southward and then again westward along the footpath leading from New Ley to Burnley-road (thereby passing through New Ley Wood and under the Burnley Branch of the Lancashire and Yorkshire Railway) for a distance of twenty chains or thereabouts to the point where the said footpath meets Burnley-road and extending thence north-west-ward along the middle of Burnley-road for a distance of three chains or thereabouts to its junction with the roadway leading to the house called Barewise and extending thence south-westward and in a straight line for a distance of forty-three chains or thereabouts to the point on Lower Moor where the road known as Tower Causeway is crossed by the footpath leading from the house called Wet Shaw to the house called Woodfield Top and extending thence south-westward along the last-mentioned footpath for a distance of sixteen chains or thereabouts to the point where it crosses the middle of the roadway or pathway leading from Todmorden over Flower Scar Hill to Sharneyford upon the boundary which divides the said new parish of All Saints Harley Wood from that portion of such new parish which by the said Order in Council dated the twenty-ninth day of January one thousand eight hundred and ninety-four was prospectively annexed to the parochial chapelry of Todmorden."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Wakefield.

HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the seventh and eighth years of Her late Majesty Queen Victoria, chapter ninety-four; of the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninety-four, and of the Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four, duly prepared and laid before His Majesty in Council a scheme or representation, bearing date the twelfth day of February, in the year one thousand nine hundred and three, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, acting under the provisions of the Act of the seventh and eighth years of Her late Majesty Queen Victoria chapter ninety-four of the Act of the thirteenth and fourteenth years of Her said late Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Christ Church Harpurhey-cum-Moston and of the new parish of Saint Stephen
