the patron and to the Incumbent of the cure out of which it is intended that the district recommended in such scheme to be constituted shall be taken, and such patron and Incumbent have respectively signified their assent to such scheme.

And whereas the said scheme has been approved by His Majesty in Council: now, therefore. His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Manchester. W HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the seventh and eighth years of Her late Majesty Queen Victoria, chapter ninetyfour; of the Act of the thirteenth and fourteenth years of Her said late Majesty, chapter ninetyfour, and of the Act of the thirty-second and thirty-third years of Her said late Majesty, chapter ninety-four, duly prepared and laid before His Majesty in Council a scheme or representation, bearing date the twelfth day of February, in the year one thousand nine hundred and three, in the words following, that is to say:— "We the Ecclesiastical Commissioners for

"We the Ecclesiastical Commissioners for England acting under the provisions of the Act of the seventh and eighth years of Her late Majesty Queen Victoria chap'er ninety-four of the Act of the thirteenth and fourteenth years of Her said late Majesty chapter ninety-four and of the Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninetyfour have prepared and now humbly lay before Your Majesty in Council the following scheme or representation for altering the boundaries of the new parish of Saint Barnabas, Kensington, in the county of Middlesex, and in the diocese of London.

"Whereas by the authority of an Order of Her said late Majesty in Council bearing date the twenty-seventh day of August in the year one thousand eight hundred and forty-two and published in the London Gazette upon the fifteenth day of November following a part of the parish of Saint Mary Abbotts, Kensington, in the said county of Middlesex and diocese of London, was assigned as a chapelry district to the consecrated church of Saint Barnabas situate in the said parish and such chapelry district was named 'The Chapelry District of Saint Barnabas, Kensington.'

"And whereas the said chapelry district of Saint Barnabas, Kensington, has under the provisions of the Act of the nineteenth and twentieth years of Her said late Majesty chapter one hundred and four, become a new parish of the character contemplated by that Act, and by the Act of the sixth and seventh years of Her said late Majesty, chapter thirtyseven and by the above-mentioned Act of the thirty-second and thirty-third years of Her said late Majesty chapter ninety-four.

"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of Saint Barnabas, Kensington, should be altered in the manner which is hereinafter mentioned.

" Now therefore with the consent of the Right Honourable and Right Reverend Arthur Foley Bishop of the said diocese of London (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent recommend and propose that from and after the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said new parish of Saint Barnabas Kensington shall be altered so that all that portion of the said parish of Saint Mary Abbotts Kensington which is described in the Schedule hereunder written and is delineated and set forth upon the map or plan hereunto appended and is thereon coloured pink shall be dissevered from such parish and shall be annexed to and shall in future form part of the said new parish of Saint Barnabas, Kensington.

"And we further represent recommend and propose that nothing herein contained shall prevent us from representing recommending or proposing any other measures relating to the matters aforesaid or any of them, in accordance with the provisions of the hereinbefore mentioned Acts or of any of them or of any other Act of Parliament.

"The SCHEDULE to which the foregoing

Scheme or Representation has reference.

"The territory to be annexed to the new parish of Saint Barnabas Kensington in the county of Middlesex and in the diocese of London being:—

"All that portion of the parish of Saint Mary Abbotts Kensington in the said county and diocese which is bounded upon the southwest and upon the south-east by the said new parish of Saint Barnabas Kensington, and upon the remaining sides, that is to say upon the north-east and upon the north-west by an imaginary line commencing at the point where the boundary which divides the said new parish of Saint Barnabas Kensington from the said parish of Saint Mary Abbotts Kensington crosses the middle of Abbotsbury-road and extending thence north-westward along the middle of Abbotsbury-road for a distance of three chains and a half or thereabouts to its junction with the old private road leading from Holland House into Addisonroad and extending thence south-westward along the middle of the said private road for a distance of three chains and a half or thereabouts to the boundary which divides the said parish of Saint Mary Abbotts Kensington from the said new parish of Saint Barnabas Kensington.

And whereas drafts of the said scheme or representation have been transmitted to the patrons and to the Incumbents of the cures affected by the arrangements which are contemplated by such scheme or representation and such patrons and Incumbents have respectively signified their assent thereto.
