BOARD OF EDUCATION.

Appointed Day.

Order made under Section 27 (2) of the Education Act, 1902.

Whereas by Sub-section (2) of Section 27 of the Education Act, 1902 (hereinafter referred to as "the Act"), it is enacted that the Act shall, except as expressly provided, come into operation on the appointed day, and the appointed day shall be the twenty-sixth day of March, nineteen hundred and three, or such other day, not being more than eighteen months later, as the Board of Education may appoint, and different days may be appointed for different purposes and for different provisions of the Act and for different Councils.

And whereas by an Order dated the sixteenth day of March, nineteen hundred and three, the Board of Education have fixed the first day of April, nineteen hundred and three, as the appointed day for the purposes of Sub-section 5 of Section 23 of the Act.

Now, therefore, the Board of Education, pursuant to the Act and every other power enabling them in that behalf, do hereby appoint as the appointed day for each of the Councils of the boroughs and urban districts specified in the Schedule to this Order, for all purposes and provisions of the Act, so far as those purposes or provisions affect each of the said Councils, except for the purpose of Sub-section 5 of Section 23 of the Act, the first day of May, nineteen hundred and three, or such later day or days as the Board may, in the case of any such Council, for any such purpose or provision hereafter appoint.

And whereas by an Order dated the sixteenth day of March, nineteen hundred and three, the Board of Education have fixed the first day of April, nineteen hundred and three as the appointed day for the purposes of Sub-section 5 of Section 23 of the Act.

Now, therefore, the Board of Education, pursuant to the Act and every other power enabling them in that behalf, do hereby appoint as the appointed day for each of the Councils of the boroughs and urban districts specified in the Schedule to this Order, for all purposes and provisions of the Act, so far as those purposes or provisions affect each of the said Councils, except for the purpose of Sub-section 5 of Section 23 of the Act, the first day of June, nineteen hundred and three, or such later day or days as the Board may, in the case of any such Council, for any such purpose or provision hereafter appoint.
