And whereas by an Order dated the sixteenth day of March, nineteen hundred and three, the Board of Education have fixed the first day of April, nineteen hundred and three, as the appointed day for the purposes of Sub-section 5 of Section 23 of the Act.

Now, therefore, the Board of Education, pursuant to the Act and every other power enabling them in that behalf, do hereby appoint as the appointed day for the Council of the borough specified in the Schedule to this Order, for all purposes and provisions of the Act, so far as those purposes or provisions affect the said Council, except for the purpose of Sub-section 5 of Section 23 of the Act, the first day of October, nineteen hundred and three, or such later day or days as the Board may, in the case of the said Council, for any such purpose or provision hereafter appoint.

# Appointed Day.

Order made under Section 27 (2) of the Education Act, 1902.

And whereas by Section 3 of the Act it is enacted that the Council of any non-county borough or urban district shall have power as well as the County Council to spend such sums as they think fit for the purpose of supplying or aiding the supply of education other than elementary provided that the amount raised by the Council of a non-county borough or urban district for the purpose in any year out of the rates under the Act shall not exceed the amount which would be produced by a rate of one penny in the pound.

in the pound. And whereas by Orders dated the twentieth and twenty-fourth days of March, nineteen hundred and three, the Board of Education have tixed the appointed day for the Councils of counties named in the Schedule to those Orders.

Now, therefore, the Board of Education, pursuant to the Act and every other power enabling them in that behalf, hereby appoint the appointed day for the purposes of Section 3 of the Act, and of so much of the Act as is consequential upon, or incidental to, the powers and duties conferred by that Section, for the Council of each noncounty borough and urban district having a population, in the case of a borough, of ten thousand or less, and, in the case of an urban district, of twenty thousand or less, and the appointed day shall be, in the case of the Council of each such non-county borough or urban district, the day appointed as the appointed day for the purposes of Part II of the Act for the Council of the county in which each such noncounty borough or urban district is comprised, or such later day as the Board of Education may, in the case of the Council of each such county, hereafter appoint.
