Now, therefore, the Board of Education, pursuant to the Act and to every other power enabling them in that behalf, hereby appoint as the appointed day for the said Council for all purposes and provisions of the Act, except for the purposes of Sub-section (5) of Section 23 aforesaid, the first day of July, nineteen hundred and three, or such later day or days as the Board may for any such other purpose or provision for the said Council hereafter appoint.
