mean the Committee appointed by the Corporation for the time being to undertake the control and management of the tramways; the word "car" means any carriage or car run upon the tramways for the conveyance of passengers; the word "conductor" means any officer or servant of the Tramways Committee having charge of or helping in the charge of a car; and the word "driver" means any officer or servant of the Tramways Committee driving or helping to drive a car.

Entering and leaving Cars.

2. Every passenger shall enter or depart from a car by the step of the hindermost or conductor's platform, and not otherwise, unless so directed by the conductor.

All persons desiring to alight from any car shall do so before any person boards such car for the purpose of travelling thereon, and all persons desiring to board the car shall permit such persons to alight as aforesaid.

Smoking.

3. No person shall smoke or carry a lighted pipe, cigar, or cigarente inside any car, except in a compartment especially set apart for the purpose.

Musical Instruments.

4. No passenger or other person shall, whilst travelling in or upon any car, play or perform upon any musical instrument.

Intoxicated and Infected Persons.

5. No person in a state of intoxication, or affected with any dangerons or contagious disorders, shall enter or mount upon any car, and any such person found in or upon any car shall, upon the request of the conductor, leave such car, and in the event of refusal to leave, shall be removed by or under the direction of the conductor.

Objectionable Persons.

6. No person whose dress or clothing might in the opinion of the conductor of a car soil or injure the linings or cushions of the car, or the dress or clothing of any passenger, nor any person who, in the opinion of the conductor, might, for any other reason, be offensive to any passenger, shall be entitled to enter or remain in or upon any car, and may be prevented from entering or remaining in or upon any car.

No such person shall enter in or upon any car after having been requested not to do so by the conductor, and if any such person be found in or upon any car, he shall, on the request of the conductor, leave such car, upon the fare, if previously paid, being returned.

Obscene or Offensive Language.

7. No person shall swear or use obscene language whilst in or upon any car, or spit or commit any nuisance in or upon or against any car, or willully interfere with the comfort of any passenger.

Damage to Car.

8. No person shall wilfully cut, tear, soil or danage the cushions or the linings, or remove or deface any number plate, printed or other notice, in or upon any car, or break or scratch any window of, or otherwise wilfully damage any car. Any person acting in contravention of this Byelaw shall, in addition to the penalty imposed by these Bye-laws, be liable to pay the amount of any demage so done.

Payment of Fares.

9. Each passenger shall, upon demand, pay to the conductor, or other servant of the Tramways Committee acting in the performance of his duty. the fare legally payable for the journey, or for the stage thereof for which it be demanded.

Tickets.

10. Each passenger, when tickets are issued, shall, when required so to do, show his ticket to the conductor or other servant of the Tramways Committee acting in the performance of his duty, and shall also, when requested to do so by any servant of the Tramways Committee acting in the performance of his duty, deliver up his ticket, or pay the fare legally demandable for the distance travelled over by such passenger.

Luggage.

11. No passenger shall bring on to any car any luggage other than his own personal luggage, and any such personal luggage shall be carried at the responsibility of the passenger and shall be placed by the passenger in such position on the car as shall be directed by the conductor.

Travelling on Steps, &c.

12. No person, other than the driver and conductor, or other servant of the Tramways Committee, acting in the performance of his duty, shall travel or ride upon the steps, platforms, outside rails, buffers, or guards of any car, or shall stand in any case on the outside, or, except by the express permission of the conductor, in the interior of any car.

No person except a passenger or intending passenger shall board a car, and no person shall bold or hang on by or to any part of a car.

Full Number of Passengers.

13. When any car contains in the interior thereof the full number of pas-engers for which seating accommodation, according to the notice thereof attached to a car, is provided in such interior, no person beyond such number shall enter, mount, or remain the ein, except by the express permission of the conductor first obtained.

When any car contains on the outside thereof the full number of passengers for which seating accommodation, according to the notice thereof attached to the car, is provided, no person beyond such number shall enter, mount, or remain thereon.

Entering or Leaving a Car in Motion.

14. No person shall enter, mount, or leave, or attempt to enter, mount, or leave, any car whilst in motion.

Dogs.

15. No dog or other animal shall be allowed in or upon any car, except by permission of the conductor, nor in any case in which the conveyance of such dog or other animal might be offensive or cause annoyance to passengers. No person shall take a dog or other emimal into any car after having been requested not to do so by the
