for the operations were carried out entirely by these officers under your orders, and the organization and concentration of the Field Force was

arranged by them.

Colonel Morland had command throughout of the Northern Nigeria Column, carrying out active operations, and was in sole command during the advance on, and capture of, Kano. The organization of his column was very complete, and the arrangements for supplying this large body of men and carriers worked without a hitch in spite of considerable difficulties. They reflect the greatest credit on him and on his staff. The success which has attended his handling of troops in the field marks him as an able commander.

Lieutenant-Colonel Festing, from his long experience of the country, and his knowledge of the various races, was eminently fitted for his post as Officer Commanding Line of Communications. He had a large amount of work to perform, which I consider that he carried through

with marked success and tact.

37. I wish also to express my acknowledgments to the Political Officers attached to the force at different times, viz., Captain Abadie and Major Burdon, for the assistance they rendered in obtaining intelligence and supplies.

38. I also desire to record the great assistance I have received from my Staff Officer Captain (Local Major) F. Lyon, D.S.O., a valuable officer,

of sound judgment and tact.

39. In conclusion, I wish to record the endurance and cheerfulness shown by the Native Troops and Carriers in many severe and long-continued marches, with insufficient water. Many of them suffered severely from the cold of the piercing Harmattan on the plateaus of Central Hausa land, and not a few succumbed from its effects.

As representing Your Excellency in political matters throughout the Kano-Sokoto operations, I have the honour to bring to your notice the services of the following Political Officers.

Captain and Resident Abadie accompanied me to Kano as Political and Intelligence Officer, when I was in sole command: his tact and courtesy are only equalled by his ability, and his services were invaluable.

Major Burdon acted as Political and Intelligence Officer during the advance from Kano to Sokoto. I was not then in military command, but in political matters the services he rendered were exceptional. He was also most useful in obtaining supplies; as you arrived at Sokoto shortly after its occupation it is unnecessary for me to say more.

Mr. Resident Donisthorpe.—Lieutenant-Colonel Festing, Commanding the Lines of Communication, has requested me to bring Mr. Donisthorpe's services to your notice. He was of the greatest assistance to Colonel Festing in supplying runners, carriers, &c., and preparing the camp at Wushishi, and "his unfailing courtesy was much appreciated by all officers who came in contact with him."
