WE, the Ecclesiastical Commissioners for England, in consideration of a benefaction consisting of a certain house and premises which have been permanently secured as a parsonage or house of residence for the benefice of Stoke Ferry, in the county of Norfolk, and in the diocese of Norwich, do hereby, in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty Queen Victoria, chapter one hundred and eleven, sections five and eleven, grant and appropriate out of our common fund to the said benefice of Stoke Ferry, to meet such benefaction, firstly, one capital sum of one hundred pounds, to be applicable towards defraying the cost of altering and improving the house and premises above mentioned according to plans and a specification approved by us; and, secondly, one other capital sum of six hundred pounds in respect of which, so long as the same capital sum or any part thereof shall remain in our hands, there shall be paid by us to the Incumbent for the time being of the said benefice one yearly sum of eighteen pounds or such part thereof as shall be proportionate to any balance of the same capital sum which shall so remain in our hands; the lastly-mentioned yearly payment to commence as from the twenty-eighth day of July, in the year one thousand nine hundred and three, and to be receivable in equal quarterly portions on the first day of February, the first day of May, the first day of August, and on the first day of November in each and every year.

No. 626.—ENGLAND—EAST COAST.

Lowestoft South Road—Pier Constructed, Lights.

Information, dated 16th July, 1903, has been received from Lieutenant V. Brooke Webb, R.N., that a new pier has been constructed in Lowestoft South Road, about half a mile to the southward of the harbour. This pier, known as Claremont Pier, extends from the coast in a S. 45° E. direction for a distance of 770 feet, and terminates in a T head on which two red fixed lights, placed vertically, are exhibited from a post, situated with Kirkley Church bearing S. 89° W., distant 4 cables, and St. Margaret's Church N. 5° E.

Approximate position, lat. 52° 28' N., long. 1° 45' E.

There is a depth of 16 feet at low water alongside the outer end of the pier.
