It will mark the entrance to the present South Channel. The letters M.S. will no longer be painted on the buoy.

5. The Bar buoy, conical, painted with black and white vertical stripes, situated $2\frac{8}{10}$ miles S. 61° W. from Cape Disappointment Lighthouse,

would be discontinued.

6. Clatsop Spit Buoy No. 0, red, conical, situated $2\frac{8}{10}$ miles S. 50° W. from Cape Disappointment Lighthouse, would be replaced by a black can buoy, and will in future be known as the Peacock Spit Buoy No. 0.

7. A black and white, vertically striped, conical, gas buoy would be established in a position with Cape Disappointment light bearing N 20 E., distant $2\frac{6}{10}$ miles. It will show

an occulting light.
