The KING has been pleased, by Letters Patent under the Great Seal, dated the 9th instant, to appoint the Right Honourable Arthur James Balfour, the Right Honourable Joseph Austen Chamberlain, Ailwyn Edward Fellowes, Esq., commonly called the Honourable Ailwyn Edward Fellowes, Henry William Forster, Esq., and David Alexander Edward Lindsay, commonly called Lord Balcarras, to be Commissioners of His Majesty's Treasury.

By virtue of an Act passed in the twenty-second year of the reign of Her Most Gracious Majesty Queen Victoria, intituled "An Act to extend the Act of the twenty-fourth year of King George the Third, chapter twenty-six, for issuing Writs during any Recess of the House of Commons, whether by Prorogation or Adjournment;" and of an Act passed in the twenty-sixth year of the reign of Her Majesty Queen Victoria, intituled "An Act to further limit and define the time for proceeding to Election during the Recess."

I DO hereby give notice, that it hath been certified to me in writing under the hands of two Members serving in this present Parliament in the manner required by the said Act, that Lieutenant-Colonel Arthur Hamilton Lee, late a Member serving in this present Parliament for the Southern or Fareham Division of the County of Southampton, hath accepted the Office of Civil Lord of the Admiralty, and has been gazetted thereto in the London Gazette dated the thirteenth day of October, 1903, and has thereby vacated his Seat, and that I shall issue my Warrant to the Clerk of the Crown to make out a new Writ

for the Electing of a Member to serve in this present Parliament for the said Division at the end of six days after the insertion of this notice in the London Gazette.
