WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty Queen Victoria, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant out of the common fund under our control to the Incumbent for the time being of each of the several parishes and benefices in the county of Middlesex, and in the diocese of London, which are named in the first column of the schedule hereto, a temporary yearly stipend of sixty pounds, such stipend to be payable for a period of five years, to be calculated as from the first day of November, in the year one thousand nine hundred and three, and to be receivable in four equal portions, on the first day of February, the first day of May, the first day of August, and the first day of November in each of the said five years: Provided always, that the temporary yearly stipend of sixty pounds hereby granted to each of the Incumbents of the several benefices aforesaid, shall be paid only upon the production to us, on or after each of the said lastly-mentioned days, of a certificate (in a form approved by us) under the hand of the Bishop of the diocese of London, that during the quarter then ended the Incumbent has employed within his parish one or more Assistant-Curates, with the licence or written permission of such Bishop (the number in each case being specified in the second column of the schedule hereto), and that the Curate towards whose maintenance the grant hereby secured is payable is in receipt of a salary of not less than one hundred and twenty pounds per annum.
