WILD BIRD (ENGLAND).

The Wild Birds Protection (County of Montgomery) Order, 1904.

Dated 28th January, 1904.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1902, and upon application by the County Council of the Administrative County of Montgomery, I hereby make the following Order :—

Title.

I. This Order may be cited as "The Wild Birds Protection (County of Montgomery) Order, 1904."

BIRDS.

Certain Birds protected during the whole of the Year.

II. During the period between the 31st day of July in any year and the 2nd day of March following, the killing or taking of the following species of Wild Birds is prohibited throughout the Administrative County of Montgomery:---

Common Buzzard, Goldfinch, Heron, Kestrel, Kingfisher, Kite, Owl, Redpole, Siskin.
