WILD BIRD (ENGLAND).

The Wild Birds Protection (County of Chester) Order, 1904.

Dated 14th March, 1904.

In pursuance of the powers conferred on me by the Wild Birds Protection Acts, 1880 to 1902, and upon application by the County Council of . the Administrative County of Chester, I hereby make the following Order:-

I. This Order may be cited as "The Wild Birds Protection (County of Chester) Order, 1904."

BIRDS.

Close Time Extended.

II. The time during which the killing or taking of Wild Birds or any of them, is prohibited by the Act of 1880, shall be extended, throughout the County of Chester, so as to be between the 1st day of March and the 13th day of August in any year.

Additions to the Schedule of the Act of 1880.

III. The Wild Birds Protection Act, 1880, as extended by Clause II of this Order shall apply within the whole of the County of Chester to the Heron and Kestrel as if those species were included in the Schedule to the Act.

Other Additions to the Schedule of the Act of 1880.

IV. The Wild Birds Protection Act, 1880, as extended by Clause II of this Order, shall apply within the area named in Clause V of this Order to the following species of Wild Birds as if those species were included in the Schedule to the Act:-

Common Bunting, Reed Bunting, Chiffchaff, Spotted Flycatcher, Goldfinch, Red-backed Shrike, Skylark, 'l'itlark, Missel Thrush, Pied Wagtail, Water Wagtail, Yellow Wagtail, Black-cap Warbler, Garden Warbler, Grasshopper Warbler, Sedge Warbler, Wood Warbler, Wheatear, Whinchat, Golden-crested Wren.

All Birds Protected during the Whole of the Year Within a Certain Area (Market-Garden Lands not included).

V During that period of the year to which the protection afforded by the Wild Birds Protection Act, 1880 (as extended by Clause II of this Order), does not apply, the killing or taking of Wild Birds is prohibited within the undermentioned area:

The portion of the Hundred of Wirral embracing the low-lying lands and sandhills situate between the estuaries of the Rivers Dee and Mersey, of which the boundaries shall commence to the south at a point of the main highway of the county of Chester 200 yards to the west of the Dock Cottages near "Docks" Railway Station of the Wirral Railway, run along the main highway to Bidston Village, and then turn in a northerly direction and run to Bidston Railway Station of the same railway, then turn in a westerly direction and run along the Wirral Railway until it reaches the Meols Station of such railway, then run along the highway near to the Meols Railway Station in a northerly direction to the Irish Sea, then on the north along the margin of high-water mark of the Irish Sea to a point at New Brighton where the Yellow Noses joins the said Irish Sea, and then run in a southerly direction to "Warren Drive" or road, and along "Warren Drive" to the most northerly house and grounds on the west side of such drive, then along the western boundary of the houses and premises situate along the western side of such drive or road to a point 100 yards or so from Grove-road, then turning in a westerly direction along the northern boundaries of the houses and premises in Grove-road, Wallasey, until it reaches the Wirral Railway, then turning in a southerly direction along the Wirral Railway until it reaches the Wallasey Marsh, then along the edge of the marsh in a southerly direction until it reaches the Poulton Halfpenny Bridge, then turning in a westerly direction on the edge of the said marsh until it reaches along the edge of the marsh the main highway leading from Poulton to Meols.

Provided that such parts of the area aforesaid as are market-garden lands are excepted from the operation of this Clause and of Clauses IV

and XI of this Order.

The area aforesaid (except market-garden lands, which are left uncoloured) is coloured pink and outlined in red on a map sealed with the seal of the Secretary of State, dated the 14th March, 1904, and deposited in the office of the County Council.

Further Protection for all Birds.

VI. During that period of the year to which the protection afforded by the Wild Birds Protection Act, 1880 (as extended by Clause II of this Order), does not apply, the killing or taking of Wild Birds is prohibited in such portions of the Rivers Dee and Mersey as are within the district of the Administrative County of Chester.

Additional Protection for the Gull and Tern.

VII. During that period of the year to which the protection afforded by the Wild Birds Protection Act, 1880 (as extended by Clause II of this Order), does not apply, the killing or taking of the Gull and Tern is prohibited throughout the County of Chester.

Certain Districts Exempted from the Operation of Clause VII.

VIII. I hereby exempt from the operation of Clause VII of this Order so much of the County of Chester as does not lie within the parishes of Puddington, Burton, Ness, Neston-cum-Parkgate, Gayton, Heswall-cum-Oldfield, Thurstaston, Caldy, Hoylake cum-West Kirby, Wallasey, Lower Bebington, Bromborough, Eastham, Hooton, Netherpool, Whitby, Staulow, Ince, Great Stanney, Frodsham Lordship, Weston, Runcorn, Halton, Norton, Moore, Acton Grange, Walton Inferior, including therein so much of the estuaries of the Rivers Dee and Mersey as lie within the Administrative County of Chester.

Certain Birds-Protected during the whole of the Year.

IX. During that period of the year to which the protection afforded by "The Wild Birds Protection Act, 1880" (as extended by Clause II of this Order), does not apply, the killing or taking of the following species of Wild

Birds is prohibited throughout the County of Chester:—

Bittern, Shoveller Duck, Goldfinch, Great Crested Grebe, Little Grebe or Dabchick, Herou, Kingfisher, Brown Linuet, Nightjar (Goat Sucker), Owl, Lesser Redpole, Siskin, Twite, Green Woodpecker, Great Spotted Woodpecker, Lesser Spotted Woodpecker.

Eggs.

Certain Eggs protected throughout the County.

X. The taking or destroying of the Eggs of the following species of Wild Birds is prohibited throughout the County of Chester:—

Bittern, Dunlin, Great Crested Grebe, Little Grebe or Dabchick, Blackheaded Gull, Hawfinch, Heron, Kestrel, Kingfisher, Nightjar (Goat Sucker), Owl, Oyster Catcher, Redshank, Sandpiper, Sheldrake, Shrike, Common Tern, Twite, Green Woodpecker, Great Spotted Woodpecker, Lesser Spotted Woodpecker.

All Eggs Protected within a Certain Area (Market-Garden Lands not included).

XI. The taking or destroying of the eggs of any species of Wild Bird is prohibited within the area named in Clause V for a period of five years from the date of this Order.

Repeal of former Order.

XII. The Order of the 29th March, 1901, is hereby repealed.

A Candidate who fails at the end of the year of probation to gain at least the Certificate of minimum proficiency in riding, will be liable to have his name removed from the list of selected Candidates."

The examinations in riding will be held as

(1.) Shortly after the result of the Open Competitive Examination has been declared, or at such time or times as the Commissioners may appoint during the course of the probationary year.

(2.) Again at the time of the Final Examination, Candidates, who may then fully satisfy the Commissioners of their ability to ride well and to perform journeys on horseback, will be awarded from 100 to 200 marks, according to the degree of proficiency displayed, to be added to their marks in the Final Examination. Candidates who fail to obtain 100 marks, but are reported by the Civil Service Commissioners to have reached a minimum standard of proficiency in riding, and are certified by the said Commissioners to be entitled to be appointed to the Civil Service of India, will, on their arrival in India, be subjected to such further tests in riding as may be prescribed by their Government, and shall receive no increase to their initial salary until they have passed such tests to the satisfaction of that Government.

A Candidate who fails at the end of the year of probation to satisfy the Civil Service Commissioners that he has reached the minimum standard of proficiency in riding, will be liable to have his name removed from the list of selected Candidates."

ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 5TH APRIL 1904.)

CHESHIRE (ANTHRAX) ORDER OF 1904.

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers in them vested under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

Slaughter in Anthrax and Compensation.

1.—(1.) The Council of the administrative county of Chester may, if they think fit, cause to be slaughtered any animal affected with anthrax or suspected of being so affected.

(2.) The slaughter of animals under this Article shall be conducted in such mode as will as far as

possible prevent effusion of blood.

(3.) The Council shall out of the local rate pay compensation as follows for animals slaughtered under this Article—

- (a.) where the animal slaughtered was affected with anthrax the compensation shall be onehalf of the value of the animal immediately before it became so affected; and
- (b.) in every other case the compensation shall be the value of the animal immediately before it was slaughtered.
- (4.) Provided, that if the owner of the animal gives notice in writing to the Council, or their

Inspector or other officer, that he objects to the animal being slaughtered, it shall not be lawful for the Council to cause that animal to be slaughtered except with the further special authority of the Board of Agriculture and Fisheries first obtained.

(5.) On each occasion of slaughter under this Article the Council shall send to the Board of Agriculture and Fisheries a report stating the number of animals slaughtered, the mode of slaughter and of disposal of the carcases, and the compensation paid in respect of each animal.

Extension of certain Provisions of Diseases of Animals Act, 1894.

2.—(1.) Anthrax (that is to say, the disease called or known as anthrax, splenic fever, or splenic apoplexy of animals) shall be a disease for the purposes of this Order and of sections nineteen and twenty (slaughter and compensation) of the Diseases of Animals Act, 1894.

(2.) In this Order the expression "animals" includes horses asses and mules, cattle sheep and goats and all other ruminating unimals, and

swine.

Extent.

3. This Order extends to the administrative county of Chester only.

Commencement.

4. This Order shall come into operation on the twelfth day of April, nineteen hundred and four.

Short Title.

5. This Order may be cited as the CHESHIRE (ANTHRAX) ORDER OF 1904.

Since 1890 the Hydrographic Department of the Admiralty has been collecting data showing where ice and icebergs may be met with in the southern oceans, and this has necessitated plotting the tracks of many vessels passing south of Australia, several of which have passed over or close to the position assigned to the Royal Company's Islands, without seeing them or any sign of land near them—thus, in 1892 the "Pakeha" passed one mile north of their assigned position; in 1893 the "Crusader" passed 5 miles north of them; in 1894 the "Rangatira" passed 15 miles north of them; in 1895 the "Maori" passed $2\frac{1}{2}$ miles south, and the "Rangatira" 15 miles south of them; in 1899 the "Rangatira" passed one mile south of them, and the "Matatua" 2 miles north; in 1900 the "Matatua" passed over the position in which they are supposed to be situated; in 1901 the "Karamea" passed 40 miles south of them; and in 1902 the "Pakeha" passed 12 miles south of them.

As no certain information is available as to why these islands were originally placed on the Charts, and as it is evident from the tracts plotted that no land exists in the locality in which they are marked on the charts, they have been expunged from the Admiralty publications.
