The KING, taking into His Royal consideration that, upon the decease of James Yorke Macgregor Scarlett, Baron Abinger, without issue,

which happened on or about the 11th day of December last past, the dignity of Baron Abinger devolved upon his kinsman Shelley Leopold Laurence Scarlett as eldest son and heir of Leopold James Yorke Campbell Scarlett, who was the grandson of James Scarlett, Baron Abinger, whereby according to the ordinary rules of honour the brothers and sister of the said Shelley Leopold Laurence Scarlett, now Baron Abinger, cannot enjoy that title, rank, place, and precedence which would have been due to them had their father the said Leopold James Yorke Campbell Scarlett survived his cousin the said James Yorke Macgregor Scarlett and had thereby succeeded to the title and dignity of Baron Abinger: His Majesty has been graciously pleased to ordain and declare that Robert Brooke Campbell Scarlett, Esq., Hugh Richard Scarlett, Lieutenant, Royal Field Artillery, Percy Gerald Scarlett, Esq., Leopold Florence Scarlett, Esq., and Ruth Hester Frances Scarlett, Spinster, the brothers and sister of the said Shelley Leopold Laurence Scarlett, Baron Abinger, shall henceforth have, hold, and enjoy the same title, place, rank, pre-eminence, and precedence as if their late father had survived his cousin the said James Yorke Macgregor Scarlett, and had thereby succeeded to the title and dignity of Baron Abinger:

And to command that the said Order and declaration be recorded in His Majesty's College of Arms.
