W HEREAS the Ecclesiastical Commissioners for England have, in pursuance of an Act of the sixth and seventh years of Her late Majesty Queen Victoria chapter thirty-seven. duly prepared and laid before His Majesty in Council a scheme bearing date the twenty-first day of July, in the year one thousand nine hundred and four, in the words following, that is to say:-

"We, the Ecclesiastical Commissioners for England, in pursuance of an Act of the sixth and seventh years of Her late Majesty Queen Victoria, chapter thirty-seven, sections six and eight have prepared and now humbly lay before Your Majesty in Council the following scheme for authorizing the sale and disposal of certain property formerly belonging to the Prebend of Carlton-cum-Dalby in the Cathedral Church of

Lincoln and now vested in us.

"Whereas the said Prebend of Carlton-cum-Dalby became vacant on or about the twentieth day of November in the year one thousand eight hundred and fifty-eight by the decease of the Reverend Charles Apthorpe Wheelwright the then Prebendary and upon such vacation all the lands and hereditaments theretofore belonging to the said Prebend of Carlton-cum-Dalby became absolutely vested in us for the purposes and subject to the provisions applicable to other hereditaments vested in us.

"And whereas the lands tithes and hereditaments aforesaid are not subject to any outstanding lease or grant but are now in our possession, but some portions of the said lands tithes and hereditaments are on account of their character or situation unsuitable or inconvenient to be held or applied for the purposes for which estates vested in us are applicable under the Acts by which our proceedings are governed.

" And whereas with a view to the advantageous appropriation of the said lands tithes and here-ditaments or of the proceeds thereof, for the ultimate improvement of our common fund, it is expedient that such lands tithes and hereditaments or such part or parts thereof as we shall at any time and from time to time think fit should be sold or disposed of, and accordingly that we should be empowered to sell or dispose of our interest in such lands tithes and hereditaments or in any part or parts thereof in such manner as shall appear to us advisable.

"Now therefore we humbly recommend and propose that we may be authorized and empowered by instrument or instruments in writing duly executed according to law from time to time to sell or dispose of and duly to convey according to the provisions of the said Act of the sixth and seventh years of Her said late Majesty's reign, all or any of the said lands tithes and hereditaments formerly belonging to the said prebend with their appurtenances, and all our estate right title and interest therein or in any part or any parts thereof, unto and to the use of any person or persons desirous or willing to purchase the same, and his or their heirs executors administrators or assigns or otherwise as he or they shall direct or appoint, and for such consideration as shall upon due calculation and enquiry appear to us to be just and reasonable, it being our intention to invest the proceeds of such sale from time to time as occasion may arise in the purchase of other lands, tithes, rent charges, tenements or hereditaments, or of some estate or interest therein, convenient to be held by us for the purposes of the Acts by which our proceedings are governed as aforesaid, and in the meantime to invest the proceeds in some Government or Parliamentary Stock, or other public securities in England.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the said Acts or of any other Act of Parliament.

And whereas the said scheme has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Act; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the diocese of Lincoln.
