BRISTOL BLIND ASYLUM. (Further Powers to Governing Body of Bristol Asylum for the Blind, for Acquisition, Holding, Use, and Disposal of Lands; Amendment of Bristol Blind Asylum Act, 1832, with respect to the Appointment and Constitution of the Committee of Management and the Appointment of a Chairman thereof; Appointment of Chaplain; Investment of Moneys; Agreements with Education and other Authorities; Payment of Expenses of Act; Amendment of Acts.)

NOTICE is hereby given, that the President, Vice-Presidents, Treasurer and Members of the Bristol Asylum or School of Industry for the Blind (hereinafter referred to as "the Governing Body") intend to apply to Parliament in the ensuing Session for leave to bring in a Bill for the following or some of the following purposes (that is to say):—

To confer upon the Governing Body powers to acquire and hold lands in excess of the quantity they are now authorized to hold, and to enable them to acquire and hold lands beyond the area to which their powers are now restricted.

To make further provisions with respect to the holding, use and disposal of lands belonging to the Governing Body.

To amend the provisions of the Act 2 William IV, chapter xxxix, intituled "An Act for better governing and regulating an Institution in the City of Bristol called and known by the name of 'The Bristol Asylum or School of Industry for the Illind'" (hereinafter referred to as "the Act of 1832"), with reference to the appointment of a Committee of Management, and to extend and define the powers of the Committee; to alter the number of Members of the Committee; to prescribe a qualification for service thereon, and to empower the Committee to add to their number subject to such restrictions and provisions as the Bill may define or Parliament may prescribe.

To provide for the election or appointment of a Chairman of the Committee, and to alter the existing provisions as to the appointment of the Chaplain of the Institution.

To extend the provisions of the Act of 1832 with respect to the securities in which moneys may be invested, and to appoint or provide for the appointment of Trustees of the invested funds and the property of the Institution.

To enable the Governing Body or the Committee of Management on the one hand, and any Education or other Authority or body on the other hand, to enter into and carry into effect agreements and arrangements for the reception, maintenance and employment of blind persons, and the education of blind children, and the payments to be made in respect thereof.

To provide for the payment of the expenses of the intended Act out of the funds of the Institution.

To alter, amend or extend, so far as may be necessary for the purposes of the Bill, the provisions or some of the provisions of the Act of
