WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty Queen Victoria, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant and convey to the Incumbent of the vicarage of Leighton Bromswold, in the county of Huntingdon, and in the diocese of Ely, and to his successors, Incumbents of the same vicarage, all those pieces or parcels of land, buildings and hereditaments, with the appurtenances thereunto belonging, particularly described in the schedule hereunto annexed, and now vested in us: To have and to hold the said pieces or parcels of land, buildings and hereditaments to the use of the said Incumbent and his successors for ever.
