The following Areas are now subject to the provisions of the Swine-Fever (Infected Areas) Order of 1902 :—

Berkshire.—An Area comprising the petty sessional divisions of Abingdon and Wallingford, the parishes of West Hanney, East Hanney, East Lockinge, Ardington, West Hendred, East Hendred, Harwell, and Chilton, and the boroughs of Abingdon and Wallingford, in the administrative county of Berks (26 November, 1904).

Carnarvonshire.—See under *Denbighshire and Carnarvonshire.*

Denbighshire and Carnarvonshire.—An Area comprising the petty sessional divisions of Colwyn Bay (including such detached parts of the

county of Carnarvon as are geographically situated therein), and Isdulas, and the parishes of Llansantffraid Glau Conway, Eglwysfach, and Llangerniew, in the administrative county of Denbigh (6 January, 1905).

Sussex, East.—An Area comprising the petty sessional divisions of Uckfield (except the parishes of Buxted, Framfield, East Hoathly, and Waldron), Cuckfield, Hove, and Lewes, and the boroughs of Hove and Lewes, in the administrative county of East Sussex; and also comprising the county borough of Brighton (29 December, 1904).

The provisions of the Swine-Fever (Infected Areas) Order of 1902, with modifications, have been applied to :—

Kent.—The county of Kent; the county borough of Canterbury; the borough of Bromley; the borough of Chatham; the borough of Dover; the borough of Folkestone; the borough of Gillingham; the borough of

Gravesend; the borough of Maidstone; the borough of Margate; the borough of Ramsgate; the city of Rochester; the borough of Tunbridge Wells (16 February, 1904).

The following Areas are now subject to the provisions of the Swine-Fever (Regulation of Movement) Order of 1903 :—

Ayrshire.—An Area comprising the county of Ayr, and the burghs of Ayr, Irvine, and Kilmarnock (23 June, 1904).

Breconshire, Cardiganshire, Carmarthenshire, Pembrokeshire, and Radnorshire.—An Area comprising the administrative counties of Brecon, Cardigan, Carmarthen, Pembroke, and Radnor (14 November, 1904).

Cardiganshire.—See under *Breconshire, Cardiganshire, Carmarthenshire, Pembrokeshire, and Radnorshire.*

Carmarthenshire.—See under *Breconshire, Cardiganshire, Carmarthenshire, Pembrokeshire, and Radnorshire.*

Glamorgan.—An Area comprising the administrative county of Glamorgan, including the boroughs of Aberavon and Cowbridge; and also comprising the county boroughs of Cardiff and Swansea, and the borough of Neath (14 September, 1903).

Hampshire and Isle of Wight.—An Area comprising the administrative county of Southampton, the administrative county of the Isle of Wight,

the county borough of Bournemouth, the county borough of Portsmouth, the county borough of Southampton, and the city of Winchester (1 October, 1904).

Isle of Wight.—See under *Hampshire and Isle of Wight.*

Monmouthshire.—An Area comprising the administrative county of Monmouth, including the boroughs of Abergavenny and Monmouth; and also comprising the county borough of Newport (14 September, 1903).

Pembrokeshire.—See under *Breconshire, Cardiganshire, Carmarthenshire, Pembrokeshire, and Radnorshire.*

Radnorshire.—See under *Breconshire, Cardiganshire, Carmarthenshire, Pembrokeshire, and Radnorshire.*

Staffordshire.—An Area comprising the county borough of Burton-upon-Trent (9 January, 1905).

Yorkshire (West Riding).—An Area comprising the borough of Barnsley (18 July, 1904).
