WHEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five; and of the Act of the thirty-fifth and thirty-sixth years of Her said late Majesty, chapter fourteen; duly prepared and laid before His Majesty in Council a representation, bearing date the seventeenth day of November, in the year one thousand nine hundred and four, in the words and figures following; that is to say:—

"We the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Her late Majesty, Queen Victoria, chapter seventy; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five; and of the Act of the thirty-fifth and thirty-sixth years of Her said late Majesty, chapter fourteen, have prepared and now humbly lay before Your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Peter, situate at Arkley, within the parish of Chipping Barnet, in the county of Hertford, and in the diocese of Saint Albans.

"Whereas at certain extremities of the said parish of Chipping Barnet, of the parish of Shenley, of the parish of Ridge, and of the parish of Elstree, all in the said county and diocese, and of the particular district of Saint Paul, Mill Hill, in the county of Middlesex, and in the diocese of London, which said extremities lie contiguous one to another and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such parishes and particular district.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid) of the said parish of Chipping Barnet, of the said parish of Shenley, of the said parish of Ridge, of the said parish of Elstree, and of the said particular district of Saint Paul, Mill Hill, should be formed into a consolidated chapelry for all ecclesiastical purposes and that the same should be assigned to the said church of Saint Peter, situate at Arkley as aforesaid.

"Now therefore with the consent of the Right Reverend Edgar, Bishop of Saint Albans, as such Bishop, and with the consent of the Right Honourable and Right Reverend Arthur Foley Bishop of London, as such Bishop and also as the patron (in right of his See) of the perpetual curacy of the said particular district of Saint Paul, Mill Hill, and with the consent of the Right Honourable Arthur James Balfour, First Lord of Your Majesty's Treasury, acting on behalf of Your Majesty as the patron of the rectory of the said parish of Chipping Barnet, and with the consents of Basil Gotto, of Number 29, Cheyne-walk, Chelsea, Sculptor, of Joseph Robert Ward, of Beeleigh Grange, Maldon, in the county of Essex, Esquire, and of Mary Louisa
