WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of her late Majesty Queen Victoria, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Minister or Incumbent of the district and benefice of Saint Gabriel, Bishopwearmouth, in the county of Durham, and in the diocese of Durham, and to his successors, Ministers or Incumbents of the same district and benefice, one yearly sum or stipend of one hundred pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the twenty-fourth day of January, in the year one thousand nine hundred and five, and to be receivable in equal quarterly portions on the first day of February, the first day of May, the first day of August, and the first day of November in each and every year: Provided always, that if at any time lands, tithes, or other hereditaments sufficient in our opinion to produce the said yearly sum or stipend, or any part thereof, shall be annexed by us to the said district and benefice of Saint Gabriel, Bishopwearmouth, in substitution for such yearly sum or stipend, or for such part thereof, our liability for the payment of such yearly sum or stipend, or of such part thereof, as the case may be, shall thereupon and thereafter cease and determine.

INSTRUMENT substituting the New Church, situate at Tresillian, within the united parishes of Lamorran and Merther, in the county of Cornwall, and in the diocese of Truro, for the Old Church at Merther, situate within and hitherto being the Parish Church of the same united parishes.

To all to whom these presents shall come the Ecclesiastical Commissioners for England send greeting.

WHEREAS a new church has lately been built at Tresillian, within the united parishes of Lamorran and Merther, in the county of Cornwall, and in the diocese of Truro, and has been consecrated.

And whereas the Right Reverend John, Bishop of the said diocese of Truro, as Diocesan, the Right Honourable Evelyn Edward Thomas, Viscount Falmouth, as the patron of the rectory and vicarage of the said united parishes of Lamorran and Merther, and the Reverend Frederick Edmund Watkins, Clerk in Holy Orders, as the Rector and Vicar or Incumbent of the said rectory and vicarage, have by an Instrument under their hands, bearing date on or about the twenty-fourth day of November, in the year one thousand nine hundred and four, certified to us, the said Ecclesiastical Commissioners for England, that it would be for the convenience of the said united parishes of Lamorran and Merther that the said new church, situate at Tresillian, within such united parishes, should be substituted for the old parish church, situate at Merther, of the same united parishes.

Now, therefore, we the said Ecclesiastical Commissioners for England, in exercise and execution of the power or authority in that behalf contained in the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, and in the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, and of all other powers or authorities in anywise enabling us in the same behalf, do by this Instrument, under our common seal, with the consents (testified as hereinafter mentioned) of the said John, Bishop of the said diocese of Truro, and of the said Evelyn Edward Thomas, Viscount Falmouth, and of the said Frederick Edmund Watkins, hereby declare that the said new church, situate at Tresillian, within the said united parishes of Lamorran and Merther, and duly consecrated as aforesaid, shall be and the same is hereby substituted for the said old parish church (situate at Merther as aforesaid) of the same united parishes, and that such new church shall henceforth be the parish church of the said united parishes of Lamorran and Merther, in lieu of the said old parish church, situate at Merther, as aforesaid, as fully in all respects as if the said new church, situate at Tresillian, so hereby substituted, had been originally the parish church of the same united parishes; and we, the said Ecclesiastical Commissioners for England, in further pursuance and exercise of the powers and authorities aforesaid, and with such consents as aforesaid (testified as hereinafter mentioned), do hereby transfer all the endowments, emoluments, and rights of or belonging to the said old parish church (situate at Merther as aforesaid) of the said united parishes of Lamorran and Merther, or of or belonging to the Rector and Vicar or Incumbent thereof, to the said new church, situate at Tresillian (now being by virtue of these presents the parish church of the said united parishes of Lamorran and Merther), and to the Rector and Vicar or Incumbent thereof, and his successors, for ever.

In witness whereof to these presents we, the said Ecclesiastical Commissioners for England, have set our common seal, and the said John, Bishop of the said diocese of Truro, has set his hand and affixed his episcopal seal, and the said Evelyn Edward Thomas, Viscount Falmouth, and the said Frederick Edmund Watkins have respectively set their hands and affixed their seals this twelfth day of January, in the year one thousand nine hundred and five.
