The KING has been pleased to order a Congé d'Élire to pass the Great Seal of the United Kingdom of Great Britain and Ireland, empowering the Dean and Chapter of the Cathedral Church of Gloucester to elect a Bishop of that See, the same being void by the resignation of the Right Reverend Father in God Doctor Charles John Ellicott, late Bishop thereof, and declared vacant by His Majesty's Order in Council; and His Majesty has been pleased to recommend to the said Dean and Chapter the Reverend Edgar Charles Sumner Gibson, D.D., Vicar of Leeds, to be by them elected Bishop of the said See of Gloucester.

The KING has been pleased, by Letters Patent under the Great Seal of the United Kingdom of Great Britain and Ireland, bearing date the 9th instant, to confer the dignity of a Baron of the said United Kingdom upon the Right Honourable Andrew Graham Murray, Lord Justice General and President of the Court of Session in Scotland, and the heirs male of his body lawfully begotten, by the name, style and title of Baron Dunedin, of Stenton, in the county of Perth.
