CERTIFICATE OF THE BOARD OF TRADE AUTHO-BIZING THE RAISING OF ADDITIONAL CAPITAL.

Whereas the Corringham Light Railway Company (hereinafter referred to as "the Company") have complied with the requirements of the Railway Companies Powers Act, 1864.
