Whereas a representation has been duly made to me, as Secretary of State for the Home Department, by the Llanrwst Urban District Council, that Fairs have been held at Llanrwst on the following dates, viz.:—the first Tuesday in February, and on March 8th, April 25th, May 19th, June 21st, August 10th, September 17th, October 25th, December 11th, and the second Tuesday following the last-mentioned date, and that it would be for the convenience and advantage of the public that such Fairs should, as from the 1st January, 1906, be held on the Wednesday following the first Tuesday in the months of February, March, April, May, June, August, September, October, November, and December in each year:

And whereas notice of the said representation and of the time when I would take the same into consideration has been duly published in pursuance of "The Fairs Act, 1873":

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the said Fairs should, as from the 1st January, 1906, be held on the Wednesday following the first Tuesday in the months of February, March, April, May, June, August, September, October, November, and December in each year:
