company or local authority and to supply elec-

To enable any limited company authorized to supply energy in any part of the county of London to apply for and hold shares in the Company or to provide capital for the Company or to execute any works in the area of such limited company for the company or carry out any powers relating to the supply of energy by the

Company in the county of London.

To impose limitations or restrictions upon the price which may be charged by any local authority taking energy in bulk from the Company for the supply of such energy in their respective areas of supply and to make provisions enabling any consumer of energy for motive or power purposes in any area of supply of any local authority to appeal to the Board of Trade with reference to the price charged or proposed to be charged by the local authority supplying in such area for energy supplied for motive or power purposes and to provide for the making of orders by the Board of Trade in respect of the restrictions aforesaid and for the effectual enforcement of the same.

To enable the Company on the one hand and the Metropolitan Water Board, the London County Council the Regent's Canal and Dock Company and the Lee Conservancy Board, or any of them on the other hand to enter into and carry into effect agreements with respect to the laying down or erecting in, under, over, along or across any lands, property or works of the Metropolitan Water Board or of the London County Council in, under, over, along or across the Regent's Canal and the River Lee and its tributaries and navigation as defined by "The Lee Conservancy Act, 1868, and the towing-paths. banks, foreshores or beds thereof, and any lands or property connected therewith respectively of any tubes, pipes, electric lines, cables works or apparatus, appliances and conveniences and to authorize the Company to lay down or erect tubes, pipes, electric lines, cables or works or apparatus, appliances and conveniences in accordance with the terms of any such agreement, and generally to confer upon the Company and the said Company and bodies all necessary powers for carrying into effect any agreement which may be made as aforesaid, and, if thought fit, to sanction and confirm any agreement or agreements with respect to the matters aforesaid or any of them which have been or may be entered into prior to the passing of the Bill.

To empower the Company on the lands hereinbefore described and any other lands belonging to the Company, or over which they may acquire any necessary rights, to lay down, erect, set up, maintain, renew or remove, above, under or on the surface of the ground, pipes, ducts, tubes, wires, casings, troughs, inspection boxes, manholes, posts, apparatus and other works, matters and things, and to open, break up and interfere with streets, roads, public places, footways, footpaths, level crossings, railways, tramways, rivers, foreshores, tidal lands, canals, waterways, locks, docks, wharves, towing paths, quays, piers, bridges, tunnels, culverts, sewers, drains, pipes, telegraphic, telephonic or pneumatic tubes, wires, posts and apparatus, and for those purposes or any of them to exercise in addition to other powers for similar purposes the powers or some of the powers of the Gasworks Clauses Acts, 1847 and 1871, and the Waterworks Clauses Acts, 1847 and 1863, whether with or

without modification or amendment.

To empower the Company to make attachments to buildings, walls and structures for the purpose of carrying any cable, wire or other similar work.

To authorize the Company to take and utilise for condensing and other purposes of their Undertaking, and return in whole or in part the waters of the River Ouse, and to prescribe and provide for the settlement of and the terms and conditions upon which water may be so abstracted, used or returned by the Company.

To make provision for the inspection and testing of mains, conductors and works, and for the appointment and remuneration of electrical inspectors, and for the supply, use, inspection, testing and certifying of meters, fittings and

To empower the Company to subscribe for purchase, hold and dispose of shares or stock in the capital of any company or companies giving or taking, or agreeing to give or take a supply of electrical energy to or from the Company, or establishing factories or works capable of being supplied by the Company or carrying on any Undertaking of a kind similar or sub-sidiary to the Undertaking of the Company, and to lend money on mortgage or bond or otherwise to any such Company, or to any local authority or other body or person giving or taking or agreeing to give or take such supply, and to apply the capital and funds of the Company for all or any of the purposes aforesaid, or other the purposes of the Bill.

To fix and define the respective priorities of any part or parts of the share capital of the Company or any shares or classes of shares therein and to make provisions with respect to the ranking or priorities of any loans, mortgages, debentures, bonds or other securities given by the Company, and any shares or classes of shares in the capital of the Company and the respective rights of the shareholders in, and of any persons lending money to the Company and to make provision for the appointment of a receiver and manager of the Company by any persons lending money to the Company, on such terms and subject to such conditions as the Bill may define.

To empower the Company to acquire and use patents and patent rights and licenses in respect of patented or protected inventions.

To empower the Company to manufacture, purchase, supply, erect, fit up, manitain, repair, renew, work and use dynamos, accumulators, motors, engines, batteries, fittings, lamps, meters, works, machinery, vessels, plant, stock and any materials, products, matters or things used for or in connection with generating, transmitting, transforming, distributing, supplying or utilising regulating or storing electrical energy, and to manufacture, use, sell, let for hire or otherwise deal in all articles, matters and things as aforesaid, and to exercise such powers to do such work, supply such materials and render such services as may be necessary or convenient in and for the generation, transformation, transmission, distribution, supply, utilisation, storage, regulation and measurement of electrical energy or for providing and working material for those purposes or any of them, or for manufacturing, supplying, erecting, fitting up, maintaining, renewing and repairing any such articles, matters and things as aforesaid and to make such charges therefor and in such manner as the Company think fit or as the Bill may provide.
