No. 1271.—BALTIC-GULF OF RIGA.

Pernau Approach-Shoal Marked by Buoys.

The Russian Government has given notice, dated 23rd September, 1905, of the existence of a shoal in the approach to Pernau, with a depth of 3 feet over it, in a position from which Sangö Island bears S. 50° E., distant 5½ miles, and Testama Church N. 58° E.

Approximate position, lat. 58° 15′ N., long. 23° 48′ E.

A white spar buoy, with a black downturned broom as a topmark, has been moored in a depth of 17 feet at a distance of half a mile N. 6° W. from the shoal, and a red spar buoy, with a red upturned broom as a topmark, has been moored in a depth of 24 feet at a distance of about half a mile S. 6° E. from the above shoal.

No. 1272.—BALTIC, ALAND ISLANDS— FÖGLE FIORD.

Brendö (Brandö) and Flisö-Channel Between.

The Russian Government has given notice, dated 23rd September, 1905, that a recent survey shows the existence of a channel, with a depth

of 12 feet in it, between Brendö (Brandö) and Flisö, this channel has been marked on the northern side by three spar buoys surmounted by downturned brooms, and on the southern side by three spar buoys surmounted by upturned brooms.

As the information given is not sufficient to fix the position of these buoys in detail, a note to the above effect has been placed on the Chart.

No. 1273.—BALTIC—GULF OF FINLAND, VIBORG APPROACH.

Kaukeala (Kauku Lachti)—Buoyage, Leading Marks.

The Russian Government has given notice, dated 14th September, 1905, that the buoyage and leading marks described below have been established in Kaukeala or Kauku Lachti, Gulf of Finland:—

- 1. A spar buoy, painted red and white, and surmounted by an upturned over a downturned black broom, has been moored on the eastern side of a $2\frac{1}{2}$ -fathom patch (now named Marniemi), in approximately lat. 60° 31' 40" N., long. 28° 9' 50" E.
- 2. A spar buoy, painted red and white, and surmounted by an upturned over a downturned red broom, has been moored on the northern side of a $2\frac{1}{4}$ -fathom shoal (now named Keskiluoto), in approximately lat. 60° 31′ 0″ N., long. 28° 11′ 10″ E.
- 3. A spar buoy, painted red and white, and surmounted by an upturned over a downturned red broom, has been moored on the south-eastern side of the same shoal, in approximately lat. 60° 30′ 40″ N., long. 28° 11′ 20″ E.
- 4. A spar buoy, painted black and white, and surmounted by a downturned over an upturned black broom, moored on the southern edge of a shoal (now named Tiensu), with a depth of less than 6 feet over it, in lat. 60° 31′ 0″ N., long. 28° 11′ 30″ E.

Leading marks:-

- 5. A rock at the head of the bay, in approximately lat. 60° 32′ 25″ N., long. 28° 9′ 35″ E., has been painted white to form a front leading mark.
- 6. A white mark has been painted on a cottage, in approximately lat. 60° 33′ 5″ N., long. 28° 8′ 40″ E., to form a back leading mark.

The rock painted white and the white mark on the cottage in line approximately N. 32° W. lead through the entrance to the hav

through the entrance to the bay.
