

ORDER OF THE BOARD OF
AGRICULTURE AND FISHERIES.

(DATED 6TH DECEMBER 1905.)

(SWINE-FEVER INFECTED AREA.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows :

Declaration of Swine-Fever Infected Area.

1. The Area described in the First Schedule to this Order is hereby declared to be an area infected with swine-fever for the purposes of the Swine-Fever (Infected Areas) Order of 1902.

Revocation of Poole and District (Swine-Fever) Prohibition of Movement Order of 1905.

2. The Order described in the Second Schedule to this Order is hereby revoked as from the commencement of this Order.

Commencement.

3. This Order shall come into operation on the thirtieth day of December, nineteen hundred and five.

ORDER of the Local Government Board : Temporary Order : Relief to able-bodied Men, their Wives, and Families :—

PARISH OF SAINT MARY, ISLINGTON.

To the Guardians of the Poor of the Parish of Saint Mary, Islington ;—

And to all others whom it may concern.

Whereas by a General Order, dated the 1st day of January, 1869, addressed to the Guardians of the Poor of certain Unions and Parishes, including the Parish of Saint Mary, Islington, the Poor Law Board prescribed Regulations with regard to the administration of out-door relief to poor persons in the said Parish ;

And whereas it is expedient that further provision should be made temporarily with regard to the administration of relief to certain classes of poor persons in the said Parish ;

Now, therefore, We, the Local Government Board, in pursuance of the powers given to Us by the Statutes in that behalf, hereby Order as follows :—

Article I.—The Guardians of the Poor of the Parish of Saint Mary, Islington, may, after
