"And whereas it has been represented to us and it appears to us to be expedient that the boundaries of the said new parish of the Holy Trinity, Barnstaple, and the said new parish of Newport shall be altered in the manner which is

hereinafter mentioned.

"Now therefore with the consent of the Right Reverend Archibald, now Bishop of Exeter (in testimony whereof he has signed and sealed this scheme or representation) we the said Ecclesiastical Commissioners humbly represent, recommend and propose that from and after the day of the date of the publication in the London Gazette of an Order of Your Majesty in Council ratifying this scheme or representation and without any assurance in the law other than such duly gazetted Order the boundaries of the said new parish of the Holy Trinity, Barnstaple, and the said new parish of Newport, shall be altered so that (firstly) all those portions of the said new parish of Newport, and of the said parish of Barnstaple, which are described in the first schedule hereunder written and are delineated and set forth upon the map or plan hereunto annexed and are thereon coloured green shall be dissevered from such new parish and parish respectively, and shall be annexed to and shall in future form. part of the said new parish of the Holy Trinity, Barnstaple, and (secondly) all those portions of the said parish of Barnstaple, and of the said new parish of the Holy Trinity, Barnstaple, which are described in the second schedule hereunder written and are delineated and set forth upon the said map or plan hereunto annexed and are thereon coloured pink shall be dissevered from such parish and new parish respectively, and shall be annexed to and shall in future form part of the said new parish of Newport.

"And we further represent, recommend and propose that nothing herein contained shall prevent us from representing, recommending and proposing any other measures relating to the matters aforesaid or any of them in accordance with the provisions of the hereinbefore mentioned Acts, or any of them, or any other Act of

Parliament.

"The SCHEDULES to which the foregoing Scheme or Representation has reference.

"THE FIRST SCHEDULE.

"The territory to be annexed to the new parish of the Holy Trinity, Barnstaple, in the county of Devon, and in the diocese of Exeter,

being:-

"I. All that portion of the new parish of Newport, in the said county and diocese, which is bounded upon the west by the parish of Tawstock, in the said county and diocese, upon the north-west by the said new parish of the Holy Trinity, Barnstaple, and upon the remaining sides, that is to say, upon the north-east, and upon the south-east, by an imaginary line commencing at Coney Bridge, where the bound-ary which divides the said new parish of the Holy Trinity, Barnstaple, from the said new parish of Newport, crosses the middle of Newport-road, and extending thence south-eastward along the middle of Newport-road for a distance of one chain, or thereabouts, to its junction with the road which leads along the backs of the houses called Rock Park Villas, into Rock Park, and extending thence south-westward along the middle of the above described road for a distance of three chains, or thereabouts, to its investion with the road on the eastern side

of Rock Park known as Ladies Mile, and extending thence south-westward and in a straight line (thereby crossing Rock Park) for a distance of seven chains and a quarter, or thereabouts, to the point in the middle of the River Taw, opposite to the point where it is joined by the stream called Concy Cut, upon the boundary which divides the said new parish of Newport from the said parish of Tourneteek.

from the said parish of Tawstock. "II. And also all that portion of the parish of Barnstaple, in the said county and diocese, which is bounded upon the west and upon the north by the said new parish of the Holy Trinity, Barnstaple, and upon the remaining sides, that is to say, upon the east and upon the south, by an imaginary line commencing at the point where the boundary which divides the said new parish of the Holy Trinity, Barnstaple, from the said parish of Barnstaple ceases to follow the western side of Victoria-street, and extending thence southward along the western side of Victoriastreet for a distance of two chains to its junction with the road which is numbered one upon the map annexed to this scheme or representation and extending thence north-westward along the middle of the last-mentioned road for a distance of six chains and a half, or thereabouts, to its junction with Victoria-road, and extending thence south-westward along the middle of Victoria-road for a distance of fourteen yards to the boundary which divides the said parish of Barnstaple from the said new parish of the Holy

"THE SECOND SCHEDULE.

Trinity, Barnstaple.

"The territory to be annexed to the said new parish of Newport, being:—

"I. All that portion of the said parish of Barnstaple (save and except the portion of such parish which is described in the first schedule to this scheme or representation) which is bounded upon the south by the said new parish of Newport, upon the west and upon part of the north by the said new parish of the Holy Trinity, Barnstaple, and upon the remaining sides, that is to say, upon the remaining part of the north and upon the east, by an imaginary line, commencing upon the boundary which divides the said new parish of the Holy Trinity, Barnstaple, from the said parish of Barnstaple at a point upon the western side of Victoria-street, opposite to the middle of the roadway numbered two upon the map annexed to this scheme or representation, and extending thence north-eastward to and along the middle of the said roadway for a distance of one chain and a half, or thereabouts, to a point opposite to the wall or fence forming the south-eastern boundary of the house and premises numbered 2, Clay Fieldvillas, Victoria-road, and extending thence northeastward to and along the said wall or fence and along the wall or fence forming the south-eastern boundary of the house and premises numbered 1, Clay Field-villas, Victoria-road, for a distance of one chain and a quarter, or thereabouts, to the wall or fence forming the boundary of the premises of the Great Western Railway, and extending thence first generally south-eastward and then generally southward along the last-mentioned wall or fence for a distance of thirty-two chains or thereabouts to a point in the middle of the stream called Coney Cut, upon the boundary which divides the said parish of Barnstaple from the said new parish of Newport.
