And whereas His Majesty was pleased by His Order in Council of the twenty-third day of October last, to give notice of such representations, and to order that the same should be taken into consideration by a Committee of the Lords of His Majesty's Most Honourable Privy Council, on the fourth day of December, one thousand nine hundred and five, and such Order has been published in the London Gazette, and copies thereof have been affixed, as required by the said Act :

Now, therefore, His Majesty, by and with the advice of His Privy Council, is pleased to order, and it is hereby ordered, that no new burial ground shall be opened in the said civil parishes without the previous approval of the Local Government Board, and that burials in the said parishes shall be discontinued as follows, viz. :—

**WELL.**—Forthwith and entirely in the Parish Church of Saint James, Well, in the North Riding of the county of York.

**CAWSTON.**—Forthwith and entirely in the Parish Church of Saint Agnes, Cawston, in the county of Norfolk; and in the churchyard, except as follows :—

In any vault or walled grave now existing in the said churchyard burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented.

**WESTON ZOYLAND.**—Forthwith and entirely in the Parish Church of Saint Mary, Weston Zoyland, in the county of Somerset; and in the churchyard, except as follows :—

(a.) In any vault or walled grave now existing in the said churchyard burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented :

(b.) In an earthen grave now existing in the said churchyard the burial may be allowed, at or below the depth of five feet from the surface of the ground, of the body of Mrs. Elizabeth Bawdon at her decease.
