The KING's Most Excellent Majesty in Council.

HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria chapter thirtynine, and of the Acts therein mentioned, that is

to say the Act of the third and fourth years of Her said late Majesty chapter one hundred and thirteen the Act of the fourth and fifth years of Her said late Majesty chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty chapter one hundred and fourteen, duly prepared and laid before His Majesty in Council a scheme bearing date the thirtieth day of November, in the year one thousand nine hundred and five, in the words

following, that is to say: "We the Ecclesiastical Commissioners for England in pursuance of the Act of the thirty-third and thirty-fourth years of Her late Majesty Queen Victoria chapter thirty-nine, and of the Acts therein mentioned, that is to say, the Act of the third and fourth years of Her said late Majesty chapter one hundred and thirteen, the Act of the fourth and fifth years of Her said late Majesty chapter thirty-nine, and the Act of the thirty-first and thirty-second years of Her said late Majesty chapter one hundred and fourteen, have prepared and now humbly lay before Your Majesty in Council the following scheme for effecting a transfer of the ownership of the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of Saint James, Hill, in the county of Warwick, and in the diocese of Birmingham.

"Whereas the advowson or perpetual right of patronage of and presentation to the said benefice of Saint James, Hill, is vested for an estate in fee simple without incumbrances in Albert Edward Pritchard, of Wood Green, Wednesbury, in the county of Stafford, one of Your Majesty's Justices of the Peace.

And whereas the said Albert Edward Pritchard is desirous that the whole advowson or perpetual right of patronage of and presentation to the said benefice of Saint James, Hill, now vested in him as aforesaid should be transferred to and be vested in the Bishop for the time being of the said diocese of Birmingham.

"And whereas the Right Reverend Charles, now Bishop of the said diocese of Birmingham, is willing to accept such transfer, and in token of such his willingness and also in token that the same transfer has that consent of the Bishop of the diocese which by the Acts in the hereinbefore mentioned Act recited or by some or one of them is made necessary, he, the said Charles, Bishop of the said diocese of Birmingham, has executed this scheme as hereinafter mentioned.

"And whereas the transfer of the patronage of the said benefice of Saint James, Hill, which is hereinbefore mentioned and hereinafter recommended and proposed will in our opinion tend to make better provision for the cure of souls in the parish or district in or in respect of which the right of patronage or advowson so recommended and proposed to be transferred as aforesaid arises or exists, that is to say, in the new parish of Saint James, Hill.

"Now therefore with the consent of the said Albert Edward Pritchard (in testimony whereof he has signed and sealed this scheme), and with the consent of the said Charles, Bishop of the said diocese of Birmingham (in testimony whereof he has signed this scheme and sealed the same with his episcopal seal) we the said Ecclesiastical Commissioners for England humbly recommend and propose that upon and from the day of the date of the publication in the London Gazette of any Order of Your Majesty in Council ratifying this scheme and without any conveyance or assurance in the law other than such duly gazetted Order, the whole advowson or perpetual right of patronage of and presentation to the said
