Draft of Proposed Rule to be made by the Lord Chancellor in substitution of Rule No. 18 of the Summary Jurisdiction Rules, 1886.

18. Application for Special Case.

An application to a Court of Summary Jurisdiction under section 33 of the Summary Jurisdiction Act, 1879, to state a special case shall be made in writing and shall be left with the Clerk of the Court at any time within seven clear days from the date of the proceeding to be questioned, and there shall also be left with him a copy of such application for each of the Justices constituting such Court which shall be duly forwarded by him to each of the said Justices. The case shall be stated within three calendar months after the date of the application and after the recognisance shall have been
