

patron of the vicarage of the said new parish of Saint Paul, Clapham (in testimony whereof they the said consenting parties have respectively signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent, that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of Saint Philip, Battersea, and of the said new parish of Saint Paul, Clapham, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Bartholomew, Battersea, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Bartholomew, Battersea.'

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Bartholomew, Battersea, comprising:—

"I. All that portion of the new parish (sometime consolidated chapelry) of Saint Philip, Battersea, in the county of Surrey and in the diocese of Southwark, which is bounded upon the north-west partly by the new parish of Saint Saviour, Battersea Park, and partly by the consolidated chapelry of Saint Stephen, Battersea, upon the south-west by the new parish of the Ascension, Lavender Hill, upon the south by the new parish of Saint Barnabas, Clapham Common, upon the south-east by the new parish (sometime district chapelry) of Saint Paul, Clapham, all in the said county and diocese, and upon the remaining side, that is to say, upon the east, by an imaginary line commencing at the point where the boundary which divides the said new parish of Saint Paul, Clapham, from the said new parish of Saint Philip, Battersea, crosses the middle of Queen's-road, and extending thence northward along the middle of Queen's-road for a distance of three chains and a half or thereabouts to its junction with Stanley-street, and extending thence north-westward along the middle of Stanley-street for a distance of seventeen chains or thereabouts to its junction with Broughton-street, and extending thence north-westward in a straight line for a distance of eight yards or thereabouts to the southern end of the wall or fence forming the south-western boundary of the house and premises known as No. 52, Broughton-street and extending thence north-westward along the said wall or fence for a distance of twenty-four yards or thereabouts to its northern end on the southern side of the West End and Crystal Palace Line of the London Brighton and South Coast Railway, and extending thence in a straight line due north for a distance of eight chains and a half or thereabouts (thereby crossing the said line of railway, the Ludgate Hill Branch Line of the South Eastern and Chatham Railway, the line of the West London Extension Railway, and the Low Level Line of the London, Brighton and South Coast Railway) to a point in the middle of the line of the London and South Western Railway upon the boundary which divides the said new parish of Saint Philip, Battersea, from the said new parish of Saint Saviour, Battersea Park.

"II. And also all that portion of the said new parish of Saint Paul, Clapham, which is bounded

upon the west and upon the north by the above described portion of the new parish of Saint Philip, Battersea, and upon the remaining sides, that is to say, upon the east and upon the south, by an imaginary line commencing at the point where the boundary which divides the said new parish of Saint Philip, Battersea, from the said new parish of Saint Paul, Clapham, crosses the middle of Queen's-road, and extending thence southward along the middle of Queen's-road for a distance of six chains or thereabouts to its junction with the road called Lavender Hill, and extending thence westward along the middle of Lavender Hill for a distance of two chains and three-quarters or thereabouts to the point where the boundaries of the said new parish of Saint Paul, Clapham, the said new parish of Saint Barnabas, Clapham Common, and the said new parish of Saint Philip, Battersea, all meet."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Southwark.

WHEREAS the Local Government Board, after giving to the Incumbent and the churchwardens of the parish of Saint Nicholas, Stenigot, in the parts of Lindsey, and of the parish of Saint Martin, North Nibley, in the county of Gloucester, ten days' previous notice of their intention to make such representations, have, under the provisions of the Burial Act, 1853, made representations stating that, for the protection of the public health, no new burial grounds should be opened in the civil parishes of Stenigot and North Nibley without the previous approval of the Local Government Board, and that burials should be discontinued therein, as follows, viz.:—

STENIGOT.—Forthwith and entirely in the old church of Saint Nicholas, Stenigot, in the parts of Lindsey, and in the churchyard attached thereto.

NORTH NIBLEY.—Forthwith and entirely in the Parish Church of Saint Martin, North Nibley, in the county of Gloucester; and, after the thirtieth of June, one thousand nine hundred and six, in the churchyard, except as follows:—

(a.) In any vault or walled grave now existing in the said churchyard burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented:

(b.) In any earthen grave now existing in the said churchyard burial may be allowed, at or below the depth of five feet from the surface of the ground, of the body of any member of the family of the person or persons heretofore buried in such grave.
