

opposite the northern fence of New Mill Cottages, and thence in a straight line to and along the said fence in a westerly direction to where the same meets Mill-lane, thence along the centre of Mill-lane intersecting the Great Western Railway to the point where Mill-lane meets Reading-road, thence following the said municipal borough boundary along the centre of Reading-road to the continuation of Mill-lane, thence along the said continuation of Mill-lane in a westerly direction, intersecting Harpsden-road till the said boundary leaves the course of Mill-lane near the end of Cromwell-road, thence following the said boundary intersecting Cromwell-road, Belle Vue-road, and Berkshire-road, and continuing thence to the point where the said municipal borough boundary turns to the north, thence following the said municipal borough boundary to the point where the same meets the southern boundary of Henley North Ward as hereinbefore described on Greys Hill, thence in a north-easterly and easterly direction along the said southern boundary of Henley North Ward as hereinbefore described, along the centre of Greys Hill, Greys-road, and Friday-street to the point of commencement in the River Thames aforesaid.

And I do hereby further declare that the two wards hereinbefore determined and defined are shown upon the map of the said borough hereunto annexed and signed by me and that the boundaries of the two said wards are clearly set forth in red and blue lines respectively thereon and that the boundary between the two said wards is clearly set forth by a dotted blue line thereon.

And I do hereby assign and apportion the Councillors of the said borough among the said wards as follows, to each of the two said wards six Councillors that is to say:—

WHEREAS the Local Government Board, after giving to the Incumbent and the Churchwardens of the parish of Holy Trinity, Yearsley, in the North Riding of Yorkshire, ten days' previous notice of their intention to make

such representation, have, under the provisions of the Burial Act, 1853, made a representation stating that, for the protection of the public health, no new burial ground should be opened in the civil parish of Yearsley without the previous approval of the Local Government Board, and that burials should be discontinued therein, as follows, viz.:—

YEARSLEY.—Forthwith and entirely in the church of Holy Trinity, Yearsley, in the North Riding of Yorkshire, and in the churchyard.

Now, therefore, His Majesty in Council is pleased hereby to give notice of such representation, and to order that the same be taken into consideration by a Committee of the Lords of His Majesty's Most Honourable Privy Council on the ninth day of July next:

And His Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the churches or chapels of, or on some conspicuous places within, the parish affected by such representation one month before the said ninth day of July.
