

*General Provisions as to Movement.*

3.—(1.) Swine being moved under this Order shall be moved by the nearest available route and without unnecessary delay to the bacon factory or slaughterhouse specified in the Licence, and not elsewhere.

(2.) This Order does not authorise movement of swine in a Swine-Fever Infected Place, or of swine the movement of which is prohibited by notice of an Inspector of a Local Authority or of the Board given under any Order of the Board.

*Production of Licences: Names and Addresses.*

4.—(1.) Any person in charge of a pig being moved, where under this Order a Licence is necessary, shall on demand of a Justice, or of a constable, or of an Inspector or other officer of the Board or of a Local Authority, produce and show to him the Licence, if any, authorising the movement, and shall allow it to be read and a copy of or extract from it to be taken by the person to whom it is produced.

(2.) Any person so in charge shall, on demand as aforesaid, give his name and address to the Justice, or constable, or Inspector or other officer.

*Offences.*

5.—(1.) If a person in charge of a pig being moved, where under this Order a Licence is necessary, on demand made under this Order, fails to give his true name and address or gives a false name or address, he shall be deemed guilty of an offence against the Act of 1894.

(2.) If any person, with a view unlawfully to evade or defeat the operation of this Order, by washing, or in any other manner, takes out, effaces, or obliterates, or attempts to take out, efface, or obliterate, any mark painted on any pig, as required by this Order, the person doing the same, and the person causing, directing, or permitting the same to be done, and the owner of the pig, and the person for the time being in charge thereof, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Act of 1894.

(3.) If any person fail to deliver up or send a Licence as required by this Order, he shall be deemed guilty of an offence against the Act of 1894.

*Interpretation.*

6. In this Order, unless the context otherwise requires:

“Bacon factory” means premises in which the business of a curer of bacon is carried on:

“Slaughterhouse” means any premises where animals are habitually slaughtered:

“Swine-Fever Infected Place” means a place for the time being declared to be infected with swine-fever under any Order of the Board:

“Inspector” includes Veterinary Inspector:

“The Board” means the Board of Agriculture and Fisheries:

“The Act of 1894” means the Diseases of Animals Act, 1894.

*Commencement.*

7. This Order shall come into operation on the twenty-fifth day of June, nineteen hundred and six.

*Short Title.*

8. This Order may be cited as the COVENTRY AND DISTRICT (SWINE-FEVER) PROHIBITION OF MOVEMENT (AMENDMENT) ORDER OF 1906, and

shall be read as one with the Coventry and District (Swine-Fever) Prohibition of Movement Order of 1906.

ORDER OF THE BOARD OF  
AGRICULTURE AND FISHERIES.

(DATED 21ST JUNE 1906.)

The Board of Agriculture and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

1. Notwithstanding the provisions of the Swine-Fever (Regulation of Movement) Order of 1903, or of any Order by which such provisions are applied to any scheduled area, swine may be moved to the exhibition mentioned in the Schedule hereto, and from such exhibition to any place of destination in Great Britain situate in any scheduled area, if accompanied by a Licence authorising such movement.

2. In the case of movement to the said exhibition the Licence shall be one granted by some person authorised in that behalf by the Peebles-shire County Council, and in the case of movement from the said exhibition the Licence shall be one granted by an Inspector of the Local Authority of the District in which the place of destination is situate.

3. The swine shall be moved by the nearest available route and without unnecessary delay to the exhibition or place of destination specified in the Licence and not elsewhere, and while being so moved shall not be subject to Regulations made by a Local Authority under any Order of the Board relating to Swine-Fever.
