ayments not hereinbefore mentioned) shall belong to the Incumbents of the said parishes.

"That no change, except as hereinbefore mentioned, shall be made in regard to glebe lands, tithes, or tithe rent charges, compositions in lieu of tithes, endowments, or other annual payments of or belonging to the benefices of the parishes herein referred to, nor in respect to

patronage.

"That the inhabitants of the said several districts shall be entitled to accommodation in the churches of the parishes to which they shall be respectively annexed and in common with the parishioners of those parishes and shall not henceforth be entitled to any accommodation in the churches of the parishes from which they shall be separated except nevertheless any person or persons, if any, possessing a legal right by faculty or otherwise to the exclusive use of any pews or sittings in the last mentioned churches and who may not be willing to relinquish and give up the same.

"SCHEDULE referred to in the foregoing Representation and Scheme.

"FIRST PART.

"To be added to the parish of Sutton Coldfield from the parish of Saint Michael, Boldmere.

"That portion of the parish of Saint Michael, Boldmere, lying to the east of and which is bounded on the west by Wyndley Pool and by an imaginary line from the north-west corner of Field No. 1 next Wyndley Pool and running southward to the north corner of the grounds of Stanley House, thence along the east boundary of such grounds to Jockey-lane thence eastward along the lane to the middle of the bridge over the railway thence southward along the middle of the railway to a point on the said railway about four hundred yards from the bridge at the angle formed by such line of railway and by a line drawn from the Birmingham road along the southern boundary of the field which lies to the north of the cottages belonging to the Barker Trust continued in a straight line to the point on the railway before referred to thence southward along the middle of the Birmingham road to a point in such road immediately opposite the west end of the southern boundary of Field No. 2 and thence along such southern boundary to the boundary of Holy Trinity, Sutton Coldfield, which portion so described is coloured pink on the accompanying map.

"SECOND PART.

"To be added to the parish of Saint James, Hill, from the parish of Sutton Coldfield.

"All that portion of the parish of Holy Trinity, Sutton Coldfield, which lies between the Sutton Park Wall on the north-west and the middle of Luttrell-road and the southern boundary of the property of Mr. Price known as Hartopp Grange on the south-east and coloured blue on the accompanying map.

"THIRD PART.

"To be added to the parish of Saint Michael, Boldmere, from the parish of Saint John,

Walmley.

"All that part of the parish of Saint John, Walmley, which adjoins the parish of Saint Michael, Boldmere, and which lies to the north of the municipal boundary of Sutton Coldfield and is bounded on the east by the eastern boundaries of Fields numbers 3, 4, 5, and 6, and a part of the eastern boundary of Field No. 7 coloured yellow on the accompanying map.

FOURTH PART.

"To be added to the parish of Saint John, Walmley, from the parish of Saint Michael, Boldmere:-

"All that part of the parish of Saint Michael, Boldmere, which lies to the east of the lane sometimes called Cow-lane, and coloured green on the accompanying map.

FIFTH PART.

"To be added to the parish of Saint John, Walmley, from the parish of Curdworth:

"All that portion of the parish of Curdworth sometimes called Cat Hill, which is bounded on the east and south by a line drawn along the middle of the road running southward from Walmley Ash under the railway bridge of the Water Orton and Walsall Branch Railway towards the road from Minworth to Tyburn but turning northward and thence westward to the footbridge near Platts Brook Reservoirs and thence so as to include four of and along the boundary of the said reservoirs to the northeast corner of Field No. 8 thence southward along the eastern boundary of the said field to the road leading from the canal to the road to Walmley thence along the said road westward to the said Walmley road and thence westward along the road leading to the Chester road to a point where a footpath strikes to the south then northward to the Walmley parish boundary coloured brown on the accompanying map.

"SIXTH PART.

"To be added to the parish of Curdworth from

the parish of Saint John, Walmley:

"All that part of the parish of Saint John, Walmley, known as Minworth Greaves and Wiggius Hill coloured purple on the accompanying map and which lies to the south and east of an imaginary line beginning in the middle of the road from Overgreen to Curdworth at the junction therewith of the road leading to Wiggins Hill Farm thence along the middle of the last named road to Field No. 9. thence along the northern and western boundaries of the said field thence westward along the northern boundary of Field No. 10 thence along the several western and north-western boundaries of the Fields numbers 11, 12, 13, 14, 15, 16, 17, 18 and 19, and thence along the farm road leading to Field No. 20, into the road from Overgreen to Hurst Green Farm and thence south - westward along the last mentioned road to the point where the parish boundary of Saint John, Walmley, enters the said road.

"We Charles Lord Bishop of Birmingham, patron of the benefices of Sutton Coldfield and of Saint James, Hill, the Reverend Albert Edward Riland Bedford, M.A., Patron and Vicar of the benefice of Saint Michael, Boldmere, the Reverend John Francis Forge, B.A., Vicar of Walmley, and William Hollis Briggs, of Commercial Bank-chambers, Albert-street, Derby, Solicitor, patrons of the benefice of Saint John, Walmley, and Thomas Howard Ryland, of Moxhull Park near Birmingham in the county of Warwick, and Richard Alfred Pinsent, of 6, Bennetts-hill, in the city of Birmingham, Solicitor, the patrons for the next turn of the benefice of Curdworth, being the patrons or persons as such patrons severally entitled to present to the benefices referred to in the before mentioned scheme if the same were now vacant: and

"We the Reverend William Campbell Riland Bedford, M.A., Rector of Sutton Coldfield, the
