this Order, the owner of the pig, and the person for the time being in charge thereof, and the person causing, directing, or permitting the movement, and the person moving or conveying the pig, and the consignee or other person receiving or keeping it knowing it to have been moved in contravention as aforesaid, and the occupier of the place from which the pig is moved, shall, each according to and in respect of his own acts and defaults, be deemed guilty of an offence against the Diseases of Animals Act, 1894.

Revocation of Order.

7. The Order described in the Second Schedule hereto is hereby revoked.

Commencement.

8. This Order shall come into operation on the first day of September, nineteen hundred and six. | Halifax, Huddersfield, and York.
