LIGHT RAILWAYS ACT, 1896.

*Mansfield and District Light Railways
(Extensions) Order, 1906.*

The Light Railway Commissioners have submitted to the Board of Trade, for confirmation under the above-mentioned Act, an Order made by them for the construction of Light Railways in the borough of Mansfield, and in the urban districts of Mansfield Woodhouse, and of Sutton-in-Ashfield, and in the rural district of Skegby, in the county of Nottingham, in extension of the Light Railways authorized by the Mansfield and District Light Railways Order, 1901, and for other purposes.
