And whereas notice of the said representation and of the time when the same would be taken into consideration has been duly published in pursuance of the Fairs Act, 1873:

And whereas on such representation and consideration it appears to me that it would be for the convenience and advantage of the public that the said Fairs should in future be held on the last Saturday in the months of January and February, the first Saturday in the months of April, May, and July, and the last Saturday in the months of September and November, respectively:

Now therefore I, as Secretary of State for the Home Department, in exercise of the powers vested in me by the Fairs Act, 1873, do hereby order that the Fairs, which have been held annually at Chesterfield on January 27th, February 28th, the first Saturday in April, May 4th, July 4th, September 25th, and November 25th, except when Sunday has fallen on any one of the dates named, when the Fair has been holden on the following Monday, shall in future be held annually on the last Saturday in the months of January and February, the first Saturday in the

months of April, May, and July, and the last Saturday in the months of September and November, respectively.
