of Saint Michael at Bowes, Southgate, and the new parish (sometime consolidated chapelry) of Saint Paul, New Southgate, all in the county of Middlesex, and in the diocese of London, which are comprised within and are bounded by an imaginary live commencing upon the boundary which divides the said consolidated chapelry of Saint Michael at Bowes, Southgate, from the consolidated chapelry of Palmer's Green, in the said county and diocese, at the centre of the bridge which carries the Enfield branch line of the Great Northern Railway across Pymme's Brook, and extending thence first south westward, then generally north-westward, and then again south-westward along the middle of Pymme's Brook (thereby following in part the last mentioned boundary and in part the boundary which divides the new parish of Southgate, in the said county and diocese, from the said · consolidated chapelry of Saint Michael at Bowes, Southgate), for a distance of sixty-one chains or thereabouts to the point where Pymme's Brook is joined by Bounds Green Brook and where the last mentioned boundary meets the boundary which divides the said consolidated chapelry of Saint Michael at Bowes, Southgate, from the said new parish of Saint Paul, New Southgate, and extending thence first south-westward, then south-eastward along the last mentioned boundary (thereby following the middle of Bounds Green Brook and the middle of Bowes-road) for a distance of seventeen chains and a half or thereabouts to the junction of Bowes-road with Stanley-road, and extending thence south-west-ward along the middle of Stanley-road for a distance of nineteen chains or thereabouts to its junction with Shrewsbury-road, and extending thence north-westward and in a straight line in continuation of the middle of Shrewsbury-road for a distance of one chain or thereabouts (thereby crossing the hedge at the north-western end of Shrewsbury-road) to a point in the middle of the footpath which leads along the northwestern side of the said hedge, and extending thence south-westward along the middle of the said footpath for a distance of nine chains and a half or thereabouts (thereby passing along the north-western end of Maidstone-road and crossing Tewkesbury-road) to the boundary which divides the said new parish of Saint Paul, New Southgate, from the said new parish of Saint Michael, Wood Green, and extending thence first north-westward, then south-westward and then westward along the last mentioned boundary for a distance of forty-one chains or thereabouts to the point in the middle of the main line of the Great Northern Railway where such boundary meets the boundary which divides the new parish of Saint Andrew, Alexandra Park, in the said county and diocese, from the said new parish of Saint Michael. Wood Green, and extending thence south-eastward along the middle of the last mentioned line of railway (thereby following in part the last mentioned boundary and in part the boundary which divides the district chapelry of Saint Saviour, Alexandra Park, in the said county and diocese, from the said new parish of Saint Michael, Wood Green), for a distance of seventy-four chains or thereabouts to the centre of the bridge which carries the down line of the Enfield branch of the Great Northern Railway across the main line of the same railway, and extending thence first northward and then northeastward along the middle of the said down line of railway for a distance of ten chains and a half or thereabouts to the point where it again begins to run parallel with the up line of the same branch of the railway, and extending thence first eastward to and then north-eastward along the

middle of the said Enfield branch line of railway for a distance of sixty-nine chains and a hälf or thereabouts (thereby crossing the boundary which divides the said new parish of Saint Michael, Wood Green, from the said consolidated chapelry of Saint Michael at Bowes, Southgate), to the centre of the bridge which carries such line of railway across Pymme's Brook upon the boundary which divides the said consolidated chapelry of Saint Michael at Bowes, Southgate, from the said consolidated chapelry of Palmer's Green, at which point the said imaginary line commenced."

And whereas the said representation has been approved by His Majesty in Council: now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said representation, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts; and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of London.

W HEREAS the Ecclesiastical Commissioners for England have in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy; of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven; and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five; duly prepared and laid before His Majesty in Council a representation, bearing date the twenty-sixth day of July, in the year one thousand nine hundred and six, in the words and figures following, that is to say:—

"We, the Ecclesiastical Commissioners for England, in pursuance of the Act of the eighth and ninth years of Her late Majesty Queen Victoria, chapter seventy, of the Act of the fourteenth and fifteenth years of Her said late Majesty, chapter ninety-seven, and of the Act of the nineteenth and twentieth years of Her said late Majesty, chapter fifty-five, have prepared, and now humbly lay before Your Majesty in Council the following representation as to the assignment of a consolidated chapelry to the consecrated church of Saint Alban, Leicester, situate within the new parish (sometime consolidated chapelry) of Saint Mark the Evangelist, Leicester, in the county of Leicester and in the diocese of Peterborough.

⁽ⁱ⁾ Whereas at certain extremities of the said new parish of Saint Mark the Evangelist, Leicester, and of the new parish (sometime district chapelry) of Saint Michael and All Angels, Belgrave, in the said county and diocese, which said extremities lie contiguous one to another, and are described in the schedule hereunder written, there is collected together a population which is situate at a distance from the several churches of such new parishes.

"And whereas it appears to us to be expedient that certain contiguous portions (being the portions containing the population aforesaid)
