

of the said new parish of Saint Mark the Evangelist, Leicester, and of the said new parish of Saint Michael and All Angels, Belgrave, should be formed into a consolidated chapelry for all ecclesiastical purposes, and that the same should be assigned to the said church of Saint Alban, Leicester, situate as aforesaid.

"Now, therefore, with the consent of the Honourable and Right Reverend Edward Carr, Bishop of Peterborough, as such Bishop and also as the patron (in right of his See) as well of the vicarage of the said new parish of Saint Mark the Evangelist, Leicester, as of the vicarage of the said new parish of Saint Michael and All Angels, Belgrave (in testimony whereof he has signed and sealed this representation), we, the said Ecclesiastical Commissioners for England, humbly represent that it would, in our opinion, be expedient that all those contiguous portions of the said new parish of Saint Mark the Evangelist, Leicester, and of the said new parish of Saint Michael and All Angels, Belgrave, which are described in the schedule hereunder written, all which portions, together with the boundaries thereof, are delineated and set forth on the map or plan hereunto annexed, should be united and formed into one consolidated chapelry for the said church of Saint Alban, Leicester, situate as aforesaid, and that the same should be named 'The Consolidated Chapelry of Saint Alban, Leicester.'

"We, therefore, humbly pray that Your Majesty will be graciously pleased to take the premises into Your Royal consideration, and to make such Order in respect thereto as to Your Majesty in Your Royal wisdom shall seem meet.

"The SCHEDULE to which the foregoing Representation has reference.

"The Consolidated Chapelry of Saint Alban, Leicester, comprising:—

"All those contiguous portions of the new parish (sometime consolidated chapelry) of Saint Mark the Evangelist, Leicester, and of the new parish (sometime district chapelry) of Saint Michael and All Angels, Belgrave, both in the county of Leicester and in the diocese of Peterborough, which are comprised within and are bounded by an imaginary line commencing upon the boundary which divides the new parish of Saint Matthew, Leicester, in the said county and diocese, from the said new parish of Saint Mark the Evangelist, Leicester, at the point near the southern end of Catherine-street Viaduct where such viaduct crosses the middle of Willow Brook, and extending thence eastward along the last-mentioned boundary (thereby following the course of Willow Brook) for a distance of twenty-seven chains and a half or thereabouts to the point in the middle of the main line of the Midland Railway where such boundary meets the boundary which divides the said new parish of Saint Mark the Evangelist, Leicester, from the consolidated chapelry of Saint Barnabas, New Humberstone, in the said county and diocese; and extending thence north-eastward along the last-mentioned boundary (thereby following the middle of the said line of railway) for a distance of twenty-nine chains or thereabouts to the point where such boundary meets the boundary which divides the said new parish of Saint Mark the Evangelist, Leicester, from the said new parish of Saint Michael and All Angels, Belgrave, and extending thence north-westward along the last-mentioned boundary (thereby following in part the middle of Belper-street) for a distance of twenty-six chains or thereabouts to the junction of Belper-street with Catherine-street and extending thence

north-eastward along the middle of Catherine-street for a distance of two chains and three-quarters or thereabouts to the junction of Catherine-street with Melrose-street, and extending thence north-eastward along the middle of Melrose-street for a distance of fifteen chains and a half or thereabouts to the junction of Melrose-street with Harrison-road, and extending thence north-eastward along the middle of Harrison-road for a distance of two chains and a half or thereabouts to a point opposite to the wall or fence forming the southern boundary of the houses and premises on the southern side of Doncaster-road, and extending thence north-westward to and along the said boundary wall or fence for a distance of eight chains and a half or thereabouts to the point where such wall or fence meets the wall forming the north-western boundary of the Belgrave Public Baths, and extending thence south-westward along the last-mentioned boundary wall for a distance of one chain and a half or thereabouts to a point opposite to the middle of Cossington-street, and extending thence north-westward to and along the middle of Cossington-street for a distance of four chains or thereabouts to the junction of Cossington-street with Belgrave-road, and extending thence south-westward along the middle of Belgrave-road (thereby following for a short distance the boundary which divides the said new parish of Saint Michael and All Angels, Belgrave, from the said new parish of Saint Mark the Evangelist, Leicester), for a distance of thirteen chains and three-quarters or thereabouts to the junction of Belgrave-road with Rothley-street, and extending thence south-eastward along the middle of Rothley-street for a distance of three chains and a half or thereabouts to the junction of Rothley-street with Rendell-road, and continuing south-eastward in the same direction and in a straight line for a distance of eight yards or thereabouts to the wall or fence forming the north-western boundary of the Belgrave Recreation Ground and extending thence first south-westward and then eastward along the walls or fences forming the boundary of the Belgrave Recreation Ground for a distance of eight chains or thereabouts to a point opposite to the middle of Allington-street, and extending thence southward to and along the middle of Allington-street for a distance of two chains and a quarter or thereabouts to a point opposite to the wall or fence forming the southern boundary of the houses and premises on the southern side of Burfield-street, and extending thence south-eastward to and along the last-mentioned boundary wall or fence for a distance of twelve chains and three-quarters or thereabouts to the point where such boundary wall or fence meets the wall or fence forming the boundary between the house and premises known as Number 58, Catherine-street, and the house and premises known as Number 56, Catherine-street, and extending thence south-eastward along the last-mentioned boundary wall or fence for a distance of eighteen yards or thereabouts to its eastern end on the western side of Catherine-street, and extending thence first south-eastward to the middle of Catherine-street and then south-westward along the middle of Catherine-street and along the middle of Catherine-street Viaduct for a distance of twenty-chains and a half or thereabouts to the point near the southern end of the Catherine-street Viaduct where such viaduct crosses the middle of Willow Brook upon the boundary which divides the said new parish of Saint Mark the Evangelist, Leicester, from the said new parish of Saint Matthew, Leicester, at
