Railway intersects the centre line of Deansgate, proceeding thence in a southerly direction along the centre line of Deansgate to and along the centre line of Bargate to the point where the centre line of Bargate intersects the centre line of Weelsby-road, thence in an easterly direction along the centre line of Weelsby-road to the point where the centre line of Weelsby-road intersects the boundary between the parishes of Great Grimsby and Clee, thence in a northerly direction along the parish boundary aforesaid to the point where that parish boundary intersects the centre line of the Great Northern Railway, thence in a northerly direction along the centre line of the Great Northern Railway to the point where the centre line of the Great Northern Railway meets the centre line of the Great Central Railway, thence in a south-westerly and westerly direction along the centre line of the Great Central Railway to the point of commencement aforesaid.

And I hereby determine that the Humber Ward shall comprise so much of the borough as is contained within a line commencing at the point in the River Humber where the northern boundary of the borough intersects the eastern boundary of the borough, proceeding thence in a southerly direction along the boundary of the borough to the point opposite the centre line of Oxfordstreet, thence in a westerly direction along the centre line of Oxford-street to the boundary between the parishes of Great Grimsby and Clee, thence in a northerly, easterly, and northerly direction along the parish boundary aforesaid, to the point in the River Humber where the parish aforesaid intersects the northern boundary boundary of the borough, thence along the boundary of the borough in an easterly direction to the point of commencement aforesaid.

And I hereby determine that the Wellington Ward shall comprise so much of the borough as is contained within a line commencing at the point on the eastern boundary of the borough in Parkstreet opposite the centre line of Oxford-street, proceeding southwards along the eastern boundary of the borough to the point opposite the centre of Wellington-street, thence in a westerly direction along the centre line of Wellington-street to the boundary between the parishes of Great Grimsby and Clee, thence in a north-easterly and northerly direction along the parish boundary aforesaid, to the centre line of Oxford-street, and thence in an easterly direction along the centre line of Oxford-street to the point of commencement aforesaid.

And I hereby determine that the Hainton Ward shall comprise so much of the borough as is contained within a line commencing at the point in the boundary between the parishes of Great Grimsby and Clee in the centre of Welholmeroad, and proceeding thence in a northerly and north-easterly direction along the parish boundary aforesaid to the centre line of Wellington-street, thence in an easterly direction along the centre line of Wellington-street to the point opposite the centre of Convamore-road, thence in a southerly direction along the centre line of Convamore-road to the centre line of Welholme-road, thence in a westerly direction along the centre line of Welholme-road, thence in a westerly direction along the centre line of Welholme-road to the point of commencement aforesaid.

And I hereby determine that the Clee Ward shall comprise so much of the borough as is contained within a line commencing at the point in Welholme-road opposite the centre of Convamore-road, proceeding thence in a northerly direction along the centre line of Convamore-road to the centre line of Wellington-street, thence in an

easterly direction along the centre line of Wellington-street to the eastern boundary of the borough at the centre line of Park-street, thence along the borough boundary in a south-easterly, north-easterly, south-easterly and south-westerly direction to the point where the centre line of the stream which crosses Weelsby-road nearly opposite the end of Humberstone-avenue intersects the said boundary, thence in a north-westerly direction along the centre line of the said stream to the point opposite the centre line of Welholme-road, thence in a westerly direction in a straight line to and along the centre line of Welholme-road to the point of commencement aforesaid.

And I hereby determine that the Weelsby Ward shall comprise so much of the borough as is contained within a line commencing at the point in the boundary between the parishes of Great Grimsby and Clee in the centre of Welholme-road, proceeding thence in a southerly, easterly and southerly direction along the parish boundary aforesaid to the point where the parish boundary aforesaid intersects the southern boundary of the borough, thence along the borough boundary in an easterly direction to the point where the centre line of the stream which crosses Weelsby-road nearly opposite the centre of Humberstone-avenue intersects the said boundary, thence in a north-westerly direction along the centre line of the said stream to the point opposite the centre line of Welholme-road, thence in a westerly direction in a straight line to and along the centre line of Welholme-road to the point of commencement aforesaid.
