ORDER OF THE BOARD OF AGRICULTURE AND FISHERIES.

(DATED 24TH JANUARY 1907.)

The Board of Agriculture.and Fisheries, by virtue and in exercise of the powers vested in them under the Diseases of Animals Acts, 1894 to 1903, and of every other power enabling them in this behalf, do order, and it is hereby ordered, as follows:

For the purposes of the Swine-Fever (Regulation of Movement) Order of 1903 in its applica-tion to the two Scheduled Areas described in the Schedule hereto, and therein numbered I and II, swine shall not by reason of their movement from Area No. 11 by road to Malton Railway Station for movement by railway to a place of destination outside Area No. I, either be deemed to be moved into Area No. I, or if the place of destination is in Area No. II, be deemed to be moved into the latter Area: Provided that the swine are accompanied by a licence authorising their movement to the place of destination granted by the Local Authority of the District in which such place is situate, or by an Inspector of such Local Authority under the Swine-Fever Order or Regulations in force in such District, or if no such licence is available, then the swine must be accompanied by a licence granted by an Inspector of the Local Authority of the North Riding of the county of York, which licence the Inspector is hereby authorised to grant.
