WE, the Ecclesiastical Commissioners for England, acting in pursuance of the Act of the twenty-ninth and thirtieth years of Her late Majesty Queen Victoria, chapter one hundred and eleven, section five, do hereby, subject as hereinafter mentioned, grant to the Incumbent for the time being of the vicarage of Esh, in the county of Durham, and in the diocese of Durham, one yearly sum or stipend of sixty pounds, such yearly sum or stipend to be payable out of the common fund under our control, and to be calculated as from the twenty-first day of December, in the year one shousand nine hundred and six, and to be receivable in four equal portions, on the first day of February, the first day of May, the first day of August, and the first day of November in each and every year: Provided always, that the annual sum or stipend so granted by us to the Incumbent of the said vicarage of Esh shall be paid only upon the production to us on or after each of the said lastly-mentioned days in each and every year of a certificate under the hand of the Bishop of the said diocese of Durham, that an assistant curate, duly licensed by such Bishop, has been employed within the conventional district called or known as Ushaw Moor, comprising portions of the parishes of Esh and Saint Edmund, Bear Park, both in the county and diocese aforesaid, during the quarter then ended. Provided also, that such yearly sum or stipend shall continue payable as aforesaid so long only as may to us appear to be expedient under the circumstances from time to time affecting the said parishes.

Tampico River Entrance—Light Unreliable, Depths on Bar.

Information, dated 21st December, 1906, has been received through the Board of Trade, that the action of the white group flashing light at La Barra, Tampico River entrance, is unreliable; sometimes it shows as a white fixed light for upwards of an hour, at other times as group

flashing showing three flashes every ten seconds. Approximate position, lat. 22° 15³/₄' N., long. 97° 49' W.

The depths on the bar at present are reported to be from 25 to 26 feet at high water, and from 23 to 24 feet at low water, but owing to the washing away of the northern breakwater, by strong currents and freshets, dangerous obstructions may exist in the entrance.

The attention of Mariners is directed to the information respecting this bar, and the caution with regard to "Northers" and the employment of pilots given in the West India Pilot, Vol. I, 1903, page 496, and the Supplement, 1906, relating to that volume, page 30. Strangers should not attempt to enter without a pilot.
