

to be in due and proper form, have agreed to and concluded the following Articles:—

#### ARTICLE I.

The following crimes are added to the list of crimes numbered one to ten in the first Article of the said Convention of the twelfth July, one thousand eight hundred and eighty-nine, and to the list of crimes numbered eleven to thirteen in Article I of the Supplementary Convention concluded between the United States and Great Britain on the thirteenth December, one thousand nine hundred, that is to say:—

14. Bribery, defined to be the offering, giving, or receiving of bribes made criminal by the laws of both countries.

15. Offences, if made criminal by the laws of both countries, against bankruptcy law.

#### ARTICLE II.

The present Convention shall be considered as an integral part of the said Extradition Conventions of the twelfth July, one thousand eight hundred and eighty-nine, and the thirteenth December, one thousand nine hundred, and the first Article of the said Convention of the twelfth July, one thousand eight hundred and eighty-nine, shall be read as if the lists of crimes therein contained had originally comprised the additional crimes specified and numbered fourteen and fifteen in the first Article of the present Convention.

The present Convention shall be ratified, and the ratifications shall be exchanged either at Washington or London as soon as possible.

It shall come into force ten days after its publication in conformity with the laws of the High Contracting Parties, and it shall continue and terminate in the same manner as the said Convention of the twelfth July, one thousand eight hundred and eighty-nine.

In testimony whereof the respective Plenipotentiaries have signed the present Convention in duplicate, and have thereunto affixed their seals.

Done at London, this twelfth day of April, one thousand nine hundred and five.

And whereas the ratifications of the said Convention were exchanged at Washington on the twenty-first day of December, one thousand nine hundred and six.

Now, therefore, His Majesty, by and with the advice of His Privy Council, and in virtue of the authority committed to Him by the said recited Acts, doth order, and it is hereby ordered, that from and after the twenty-second day of February, one thousand nine hundred and seven, the said Acts shall apply in the case of the United States and of the said Convention with the President of the United States of America.

Provided always that the operation of the said Acts shall be and remain suspended within the Dominion of Canada so long as an Act of the Parliament of Canada passed in 1886, and entitled "An Act respecting the Extradition of Fugitive Criminals," shall continue in force there, and no longer.

**W**HEREAS by subsection seven of section seventy-six of the Local Government Act, 1888, it is enacted that it shall be lawful for

Her Majesty the Queen, by Order in Council, from time to time to alter the instructions, precepts, notices and forms under the Registration of Electors Acts, in such manner as appears to Her Majesty necessary for carrying into effect the said Act and the County Electors Act, 1888, and any other Act for the time being in force amending or affecting the Acts above mentioned.

And whereas it appears necessary to His Majesty for the aforesaid purpose that the instructions, precepts, notices, and forms now in force under the Registration of Electors Acts, being those set out in the Registration Order, 1895, should be altered in manner provided by this Order.

Now, therefore, His Majesty, by and with the advice of His Privy Council, and by virtue of the authority committed to Him by the said Local Government Act, 1888, and of all other powers enabling Him on that behalf, doth declare it, and it is hereby declared, to be necessary for carrying into effect the Local Government Act, 1888, and the County Electors Act, 1888, and the other Acts in force amending or affecting the said Acts, or the Registration of Electors Acts, that the instructions, precepts, notices, and forms under the said Registration of Electors Acts, as set out in the Registration Order, 1895, should be altered in manner appearing in the Schedule to this Order, and so that the instructions, precepts, notices, and forms as so altered should be the instructions, precepts, notices, and forms under the Registration of Electors Acts.

And it is hereby ordered that the former instructions, precepts, notices and forms shall be altered accordingly, and that the instructions, precepts, notices and forms in the schedules to the Registration Order, 1895, as altered in manner appearing in the schedule to this Order, shall be observed and be valid in law.

This Order may be cited as the Registration Order, 1907.

#### SCHEDULE.

Alterations of Registration Order, 1895.

1. Form A. in the Second Schedule to the Registration Order, 1895, and Form A. in the Third Schedule to that Order (being the forms of the requisitions by overseers requiring the names of inhabitant occupiers in a parish not in a parliamentary borough and in a parish in a parliamentary borough respectively) shall be altered by the substitution in both cases of the following paragraph for paragraph 16 in the Instructions for filling up those Forms:—

"16. If the landlord of a house let out in separate tenements lives in the house, he must return the names of the occupiers of tenements in the house where the occupier has the sole and exclusive use of the tenement free from any control of the landlord."

2. In the form of the lodger's notice of claim, in a parish in a parliamentary borough, being Form H., No. 2, in the Third Schedule to the said Order, the word "claimant" shall be substituted for the words "[here state name of claimant]" in the witness's declaration.
