To be Honorary Commander :

4th January, 1907. Captain Joseph Ritter von Schwarz, Austro-Hungarian Imperial Navy.

To be Member of the Fourth Class :

19th January, 1907. Frederick James Walker, Esq., on relinquishing the post of Honorary Secretary of "The Duke of Albany Memorial Church Society," Cannes.

PRESENT :

The KING's Most Excellent Majesty in Council.

WHEREAS the Ecclesiastical Commissioners for England have, in pursuance of the Acts of the third and fourth years of Her late Majesty Queen Victoria, chapter one hundred and thirteen, of the thirty-sixth and thirty-seventh years of her said late Majesty, chapter thirty-nine, and of the Act of the fiftieth and fifty-first years of Her said late Majesty, chapter twelve, duly prepared and laid before His Majesty in Council a scheme, bearing date the seventeenth day of January, in the year one thousand nine hundred and seven, in the words and figures following, that is to say :—

"We, the Ecclesiastical Commissioners for England, acting in pursuance of the Acts of the third and fourth years of Her late Majesty Queen Victoria chapter one hundred and thirteen, of the thirty-sixth and thirty-seventh years of Her said late Majesty chapter thirty-nine, and of the fiftieth and fifty-first years of Her said late Majesty chapter twelve, have prepared and now

humbly submit to Your Majesty in Council the following scheme for the establishment of an additional canonry in the cathedral church of Truro and for assigning a certain endowment for the same.

"Whereas there is not in the said cathedral church of Truro any suspended canonry.

"And whereas under and by virtue of the said Acts the Dean and Chapter of the said cathedral church of Truro have with the sanction of the Bishop of Truro the visitor of the said cathedral church laid before us a plan for effecting the objects hereinbefore mentioned, and the same plan bears the capitular seal of the said Dean and Chapter and also bears the episcopal seal and the signature of the said Bishop.

"And whereas the said plan is in the words and figures following, that is to say :—

"To the Ecclesiastical Commissioners for England.

"In the matter of the Ecclesiastical Commissioners Act, 1840, and of the Cathedral Acts Amendment Act, 1873, and of the Truro Bishoprick and Chapter Acts Amendment Act, 1887.

"We the Dean and Chapter of the cathedral church of Saint Mary in Truro with the sanction of the Right Reverend Charles William, Lord Bishop of Truro, the visitor of the same church, do, in pursuance of the provisions in that behalf contained in the above-mentioned Acts lay before you, the said Ecclesiastical Commissioners, the following

PLAN.

1. There shall be established in the cathedral church of Saint Mary in Truro one additional residentiary canonry.

2. The said residentiary canonry shall be in the patronage of the Bishop of Truro for the time being.

3. Subject to the provisions herein contained the Incumbent of the said additional residentiary canonry shall hold his office by the same tenure as the Incumbent of any other canonry in England and the law relating to other canonries in England shall so far as is consistent with the
