tenour thereof and with the circumstances of the case apply to the said additional residentiary

canonry and to the Incumbent thereof.

4. There shall be assigned to the said additional residentiary canonry an income (exclusive of any house of residence) of the net annual amount of three hundred pounds payable out of the Truro Chapter Endowment Fund established under the provisions of the Truro Chapter Act, 1878.

- 5. The income of the Incumbent of the said additional residentiary canonry shall be paid to him quarterly on the first day of January the first day of April the first day of July and the first day of October in each year or so soon after those dates as having regard to funds available for the purpose shall be reasonably practicable upon evidence being afforded satisfactory to the Ecclesiastical Commissioners or other the body or persons in whom the said Truro Chapter Endowment Fund may for the time being be vested that the term of residence kept by the Incumbent of the said additional residentiary canonry claiming such payment has been at least as long as the term hereinafter prescribed to be kept by him, or if the term of residence kept has been less than the term so prescribed then only upon a certificate being given under the hand of the Bishop that there has, in the opinion of the Bishop, been good ground for such failure to reside provided that nothing herein contained shall be deemed to prevent the residence (if required) of the Incumbent of the said additional residentiary canonry being enforced by any means by which residence in the case of Canons of cathedrals can generally be enforced.
- C. The Incumbent of the said additional residentiary canonry shall jointly with the two existing residentiary Canons provide for the due celebration of Divine worship in the cathedral church and for the other offices of the church therein.
- 7. It shall be the duty of the Incumbent of the said additional residentiary canonry to advise with the Bishop on all matters connected with the diocese of Truro whenever the Bishop shall call on him so to do.

8. The Incumbent of the said additional residentiary canonry, if the Bishop shall by writing under his hand at any time so notify, shall hold one or more of the following offices and shall perform the duties thereof as hereinafter described that is to say (i.) the office of Chancellor of the cathedral church including therein the instruction of candidates for Holy Orders the superintendence of the arrangements connected with preaching in the cathedral church the performance of the functions of Chapter Secretary and all such duties as in the judgment of the Bishop are duties usually performed by Chancellors of cathedral churches; (ii.) the office of Precentor of the cathedral church with all such duties as in the judgment of the Bishop are duties usually performed by Precentors in cathedral churches, and especially the superintendence of the choir and conduct of the musical part of Divine Service; (iii.) the office of Treasurer of the cathedral church with all such duties as in the judgment of the Bishop are duties usually performed by Treasurers of cathedral churches, and especially the conduct of the business arrangements connected with the cathedral church of Truro and the care and. guardianship of the goods and ornaments of the said cathedral church; (iv.) the office of Missioner in connection with the Church of England in the diocese of Truro with such duties as in the judgment of the Bishop the Missioner may properly be called upon to perform, and according to such rules and regulations as the Bishop for the time being shall from time to time in that behalf make or ordain by a writing or writings under his hand and seal to be deposited in the Registry of the diocese of Truro provided that all such rules and regulations may be from time to time in like manner revoked or altered by the Bishop for the time being as he shall see fit; and (v.) from the time at which the south aisle of the cathedral church shall have ceased to be the parish church the office of Sub-Dean of the cathedral church with all such duties as in the judgment of the Bishop are duties usually performed by Sub-Deans in cathedral churches, provided always that nothing herein contained shall be deemed to disqualify the Rector for the time being of the parish church for appointment to, or for holding the said additional residentiary canonry.

9. If and whenever the Incumbent of the said residentiary canonry shall at the request of the Bishop preach at a place fixed by him, or conduct any Divine Service whether in connection with any mission or otherwise in any part of the diocese, such preaching, or the conduct of such service shall be deemed to be the performance of part of his duties as such Canon residentiary and the time so occupied by him shall be deemed to be part of the period of residence prescribed

herein.

. 10. The Incumbent of the said residentiary canonry shall reside during eight months in each

year.

11. In all matters in which the Incumbent of the said residentiary canonry shall jointly with the Bishop and the two existing Canons residentiary or with the Bishop the two existing Canons residentiary and the honorary Canons as the case may be exercise any powers each individual shall have one vote, and in case of equality of votes the Bishop shall have a second or casting vote.

12. In regard to the Incumbent of the said residentiary canonry the Bishop shall so far as is not inconsistent with the provisions hereof be deemed to hold the position and exercise the

authority of Ordinary and Visitor.'

"And whereas it has been made to appear to us to be expedient that the said plan should be carried into effect as in the said hereinbefore firstly mentioned Act is mentioned.

"Now, therefore, we humbly recommend and propose, that, upon and as from the day on which any Order of Your Majesty in Council ratifying this scheme shall be published in the London Gazette, the said plan shall be carried into effect and shall have full force and operation according to the tenour thereof.

"And we further recommend and propose that nothing herein contained shall prevent us from recommending and proposing any other measures relating to the matters aforesaid, or any of them, in accordance with the said Acts or with any of them or with any other Act of Parlia-

ment."

And whereas the said scheme has been approved by His Majesty in Council: Now, therefore, His Majesty, by and with the advice of His said Council, is pleased hereby to ratify the said scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately from and after the time when this Order shall have been duly published in the London Gazette pursuant to the said Acts: and His Majesty, by and with the like advice, is pleased hereby to direct that this Order be forthwith registered by the Registrar of the said diocese of Truro.
