PRESENT,

WHEREAS by an Order made by the late Queen's Most Excellent Majesty in Council, on the eighteenth day of August, one thousand eight hundred and ninety-two, Her Majesty did, by and with the advice of the said Council, order that William John Courthope, Esquire, and Francis Hervey, commonly called The Lord Francis Hervey, or such other persons as Her Majesty might from time to time approve in the stead of them or any of them, should be Her Majesty's Commissioners for testing, in conformity with Her Majesty's Order in Council, dated the fourth June, one thousand eight hundred and seventy, or such further Order or Orders as Her Majesty, by and with the advice of Her Privy Council, had issued or might issue in that behalf, the qualifications of persons proposed to be appointed to situations or employments in Her Majesty's Civil Establishments, and also for testing, in conformity with regulations to be from time to time issued by Her Majesty's Principal Secretary of State for War, the literary qualifications of candidates for first Commissions in the Army, and for admission to the Royal Military College at Woolwich, and should hold their

offices during the pleasure of Her Majesty; the said William John Courthope, Esquire, being the First Commissioner; and should have power, subject to the approval of the Commissioners of Her Majesty's Treasury, to appoint from time to time such Assistant Examiners and others as might be required to assist them in the performance of the duties thereinafter assigned to them:
